Chapter 1 General Provisions

Purpose:

Article 1. The Regulations prescribe matters necessary to a student's learning at Hiroshima University Graduate School (hereafter, This Graduate School), based on stipulations in Article 18 of Hiroshima University Regulations (April 1, 2004 Regulation No. 1).

Aims of This Graduate School:

Article 2. Based on the principles of Hiroshima University, This Graduate School aims to contribute to the advancement of global academic culture and the improvement of the welfare of humanity by promoting basic scholarly research to master its depths, and advance general research and cutting-edge research in academic studies to pioneer new studies, and through these cultivate researchers and exceptional professionals that possess a wealth of knowledge and advanced research/practical skills.

Courses at This Graduate School:

Article 3. A master's course, doctorate course, and professional degree program shall be established at This Graduate School.

- (2) The doctorate course (excluding the Division of Biomedical Sciences /Graduate School of Biomedical and Health Sciences) shall be divided into a first term course (hereafter, First Term Doctorate Course) and a second term course (hereafter, Second Term Doctorate Course).
- (3) The First Term Doctorate Course shall be treated as a master's course.
- (4) The professional degree programs shall be the Division of Professional Development for Teachers and School Leaders/Graduate School of Humanities and Social Sciences, which shall be treated as a professional school for teacher education, and the Division of Law School/Graduate School of Humanities and Social Sciences, which shall be treated as a law school course.
- (5) Notwithstanding the stipulations of Paragraph 2, in cases where necessary for education and research, a doctorate course composed only of a Second Term Doctorate Course may be established.

Courses and Majors, etc.:

Article 4. The following courses and majors shall be established for each of the graduate schools at This Graduate School and the following courses shall be established for the basic organizations for the delivery of inter-graduate school programs.

Graduate School of Humanities and Social Sciences (Doctorate Course)

Division of Humanities and Social Sciences

Division of Educational Sciences

Division of Professional Development for Teachers and School Leaders

Division of Law School

Joint International Master's Programme in Sustainable Development (Hiroshima University and University of Graz)

Graduate School of Advanced Science and Engineering (Doctorate Course)

Division of Advanced Science and Engineering

Joint International Master's Programme in Sustainable Development (Hiroshima University and Leipzig University)

Graduate School of Integrated Sciences for Life (Doctorate Course)

Division of Integrated Sciences for Life

Graduate School of Biomedical and Health Sciences (Doctorate Course)

Division of Biomedical Sciences

Division of Integrated Health Sciences

Graduate School of Innovation and Practice for Smart Society

(2) The Joint International Master's Programme in Sustainable Development (Hiroshima University and University of Graz) of Graduate School of Humanities and Social

Sciences and Joint International Master's Programme in Sustainable Development (Hiroshima University and Leipzig University) of Graduate School of Advanced Science and Engineering shall be designated separately as Division of Joint International Programme stipulated in Article 35 of the Standards for the Establishment of Graduate Schools (Ordinance of the Ministry of Education, Science and Culture No. 28 of 1974) (hereinafter, "Division of Joint International Programme).

Admission Capacity:

Article 5. The admission capacity for This Graduate School shall be as shown in the Appended Table.

Standard Term of Study for the Master's Course and First Term Doctorate Course:

Article 6. The standard term of study for the master's course and First Term Doctorate Course shall be 2 years. However, in cases where deemed necessary for education and research, in accordance with a graduate school, etc., a major or a student's division of studies, the standard term of study may exceed 2 years, as provided for the graduate schools or basic organizations for the delivery of inter-graduate school programs (hereinafter referred to as "Graduate Schools, etc.>").

(2) Notwithstanding the stipulations of the preceding paragraph, the standard term of study may be a period of 1 year to less than 2 years for cases where education is primarily carried out for persons who have work experience and require education and research, and when there is no adverse effect to education caused by an appropriate method of class or research instruction during the day and evening, or other specified time or period, in accordance with Graduate Schools, etc., a major or a student's division of studies, as provided for in Graduate Schools, etc.

Standard Term of Study for the Second Term Doctorate Course:

Article 7. The standard term of study for the Second Term Doctorate Course shall be 3 years.

Standard Term of Study for the Division of Biomedical Sciences/Graduate School of Biomedical and Health Sciences:

Article 8. The standard term of study for the Division of Biomedical Sciences/Graduate School of Biomedical and Health Sciences shall be 4 years.

Standard Term of Study for a Professional Degree Program:

Article 9. The standard term of study for the Division of Professional Development for Teachers and School Leaders/Graduate School of Humanities and Social Sciences shall be 2 years, and the standard term of study for the Division of Law School/Graduate School of Humanities and Social Sciences shall be 3 years.

Maximum Period of Enrollment:

Article 10. The maximum period of enrollment in the same graduate school, etc. at This Graduate School shall be 4 years for the master's course, First Term Doctorate Course, and the Division of Professional Development for Teachers and School Leaders/Graduate School of Humanities and Social Sciences (Graduate Schools, etc., majors or a student's division of studies that prescribe a standard term of study other than 2 years shall be 2 times the number of years of said standard term of study), 6 years for the Second Term Doctorate Course and the Division of Law School/Graduate School of Humanities and Social Sciences, and 8 years for the Division of Biomedical Sciences/Graduate School of Biomedical and Health Sciences.

(2) Notwithstanding the stipulations of the preceding paragraph, for those students who abbreviate the period of enrollment in the Division of Law School/Graduate School of Humanities and Social Sciences pursuant to the stipulations under Article 45, Paragraph 2, the maximum period of enrollment shall be 4 years.

Academic Year:

Article 11. The academic year shall begin on April 1st and end on March 31st of the following year.

Academic Term:

Article 12. The academic year shall be divided into 2 terms, the first semester and second semester. The first semester shall be from April 1st to September 30th, and the second semester shall be from October 1st to March 31st of the following year.

(2) Each semester stipulated in the preceding paragraph may be divided into a first half and second half.

(3) The first half of the first semester shall be the first term, and the second half shall be the second term; the first half of the second semester shall be the third term, and the second half shall be the fourth term.

University Holidays:

Article 13. Regular holidays during the academic year shall be as follows.

[1] Saturdays and Sundays (Sundays and Mondays for the Management Sciences Program/Division of Humanities and Social Sciences/Graduate School of Humanities and Social Sciences)

[2] Holidays stipulated in the Act on National Holidays (Act No. 178 of 1948)

[3] Spring Holiday: April 1st to April 7th

[4] Summer Holiday: August 11th to September 30th

[5] Winter Holiday: December 26th to January 5th of the following year

(2) The president may change the university holidays specified in Item 3 to Item 5 of the preceding paragraph when special circumstances exist.

(3) Special university holidays shall be prescribed on a case-by-case basis.

- (4) When special circumstances exist, classes may be held on the university holidays prescribed in the preceding 3 paragraphs.

Chapter 2 Admission

Admission Period:

Article 14. The admission period shall be at the start of the academic year.

- (2) Notwithstanding the stipulations of the preceding paragraph, admission may occur at the start of a semester.

Qualifications for Admission:

Article 15. A person that falls under any of the following items shall be eligible for admission to the master's course, First Term Doctorate Course, or professional degree program.

[1] A person who has graduated from a university

[2] A person conferred a bachelor's degree from the National Institution for Academic Degrees and Quality Enhancement of Higher Education in accordance with stipulations set forth in Article 104, Paragraph 7 of the School Education Law (Act No. 26 of 1947; hereafter, Law)

[3] A person who has completed a 16-year course of school education in a foreign country

[4] A person who has completed a 16-year course of school education of a foreign country through the completion of class subjects in Japan conducted by a foreign school by correspondence education

[5] A person who has completed a course in Japan at an educational facility positioned as a facility that has the curriculum of a foreign university (persons who have completed such an education are restricted to those regarded as having completed a 16-year course in said foreign country's school education) under said foreign country's school education system and designated separately by the Minister of Education, Culture, Sports, Science and Technology

[6] A person conferred a degree equivalent to a bachelor's degree through the completion of a course of study of at least 3 years at a foreign university or other school (the general circumstances of those educational and research activities, etc. shall be restricted to facilities evaluated by entities certified by said foreign government or relevant facility, or equivalent facility separately designated by the Minister of Education, Culture, Sports, Science and Technology) (including the completion of said course through the completion of class subjects in Japan by correspondence education conducted by said foreign school, and completion of a course at an educational facility positioned under said foreign country's school education system that has received the designation set forth in the previous item).

- [7] A person who has completed a special course at a vocational school (restricted to a term of study of at least 4 years and the fulfillment of other standards prescribed by the Minister of Education, Culture, Sports, Science and Technology) that has been separately designated by the Minister, provided the completion occurred after a date prescribed by the Minister
- [8] A person designated by the Minister of Education, Culture, Sports, Science and Technology
- [9] A person admitted to a graduate school in accordance with Article 102, Paragraph 2 of the Law who thereafter has been recognized as having suitable academic ability for receiving a graduate school education at This Graduate School to which s/he shall be admitted
- [10] A person who has attained the age of 22 years and has been recognized through a separate admission screening at This Graduate School as having academic ability equal to, or greater than, a person graduated from a university
- [11] A person who has been enrolled in a university for at least 3 years (including a person designated by the Minister of Education, Culture, Sports, Science and Technology as having an equivalent education) and has been recognized as having acquired credits prescribed by This Graduate School with high marks

Article 16. A person that falls under any of the following items shall be eligible for admission to the Second Term Doctorate Course.

- [1] A person possessing a master's degree or professional degree (a professional degree is stipulated in Article 5-2 of the Degree Regulations (Ordinance of the Ministry of Education, Science and Culture No. 9 of 1953) based on Article 104, Paragraph 3 of the Law; hereafter, the same shall apply)
- [2] A person conferred a degree in a foreign country that is equivalent to a master's degree or a professional degree
- [3] A person who has completed class subjects in Japan conducted by a foreign school by correspondence education and been conferred a degree equivalent to a master's degree or a professional degree
- [4] A person who has completed a course in Japan at an educational facility positioned as a facility that has the curriculum of a foreign graduate school under said foreign country's school education system and designated separately by the Minister of Education, Culture, Sports, Science and Technology, and has been conferred a degree equivalent to a master's degree or a professional degree
- [5] A person who has completed a course at the United Nations University, established based on the December 11, 1972 United Nations General Assembly resolution stipulated in Article 1, Paragraph 2 of the Act on Special Measures (Act No. 72 of

1976) incidental to enforcement of the agreement between the United Nations and Japan regarding the headquarters of the United Nations University (hereafter, United Nations University), and has been conferred a degree equivalent to a master's degree

[6] A person who has completed a curriculum at a foreign school, an educational facility designated in Item 4, or the United Nations University, has passed an equivalent to the examination and screening stipulated in Article 16-2 of the Standards for Establishment of Graduate Schools, and is recognized as having academic ability equal to, or greater than, a person possessing a master's degree

[7] A person designated by the Minister of Education, Culture, Sports, Science and Technology

[8] A person who has attained the age of 24 years and has been recognized through a separate admission screening at This Graduate School as having academic ability equal to, or greater than, a person possessing a master's degree or a professional degree

Article 17. A person that falls under any of the following items shall be eligible for admission to the Division of Biomedical Sciences/Graduate School of Biomedical and Health Sciences.

[1] A person who has completed medicine, dentistry, or a 6-year term of study of pharmaceuticals or veterinary medicine at the faculty of medicine, dentistry, pharmaceuticals, or veterinary medicine at a university, and has graduated from the faculty

[2] A person conferred a bachelor's degree (the major field of study must be medicine, dentistry, or veterinary medicine) from the National Institution for Academic Degrees and Quality Enhancement of Higher Education in accordance with stipulations set forth in Article 104, Paragraph 7 of the Law

[3] A person who has completed an 18-year course (the final course must be medicine, dentistry, pharmaceuticals, or veterinary medicine) of school education in a foreign country

[4] A person who has completed an 18-year course (the final course must be medicine, dentistry, pharmaceuticals, or veterinary medicine) of school education of a foreign country through the completion of class subjects in Japan conducted by a foreign school by correspondence education

[5] A person who has completed a course in Japan at an educational facility positioned as a facility that has the curriculum of a foreign university (a person who completed such an education is restricted to those regarded as having completed an 18-year course in said foreign country's school education (the final course must be medicine, dentistry, pharmaceuticals, or veterinary medicine)) under said foreign country's school education

system and designated separately by the Minister of Education, Culture, Sports, Science and Technology

- [6] A person conferred a degree equivalent to a bachelor's degree through the completion of a course of study (a final course of study shall be in medicine, dentistry, pharmaceuticals, or veterinary medicine) of at least 5 years at a foreign university or other school (the general circumstances of those educational and research activities, etc., shall be restricted to facilities evaluated by entities certified by said foreign government or relevant facility, or equivalent facility separately designated by the Minister of Education, Culture, Sports, Science and Technology) (including the completion of said course through the completion of class subjects in Japan by correspondence education conducted by said foreign school, and completion of a course at an educational facility positioned under said foreign country's school education system that has received the designation set forth in the previous item).
- [7] A person designated by the Minister of Education, Culture, Sports, Science and Technology
- [8] A person admitted to a graduate school (restricted to courses completed in medicine, dentistry, pharmaceuticals, or veterinary medicine) in accordance with stipulations set forth in Article 102, Paragraph 2 of the Law and who thereafter has been recognized as having suitable academic ability for receiving a graduate school education at This Graduate School to which s/he shall be admitted
- [9] A person who has attained the age of 24 years and has been recognized through a separate admission screening at This Graduate School as having academic ability equal to, or greater than, a person graduated from a university
- [10] A person enrolled for at least 4 years in a university course that studies medicine, dentistry, or veterinary medicine, or a course that studies pharmaceuticals with the primary aim of cultivating practical abilities related to clinical work (including a person designated by the Minister of Education, Culture, Sports, Science and Technology as having an equivalent education) who has been recognized as having acquired credits prescribed by This Graduate School with high marks

Application Procedure for Admission:

Article 18. A person applying for admission to This Graduate School must submit to This Graduate School the separately prescribed documents (hereafter, Application Documents) with a payment of 30,000 yen for the examination fee within a specified period

- (2) In the entrance examination for the Division of Law School/Graduate School of Humanities and Social Sciences stipulated in Article 19, a selection shall take place based on the Application Documents (hereafter, 1st Selection). The examination fee in

cases where a selection limited to successful applicants takes place based on scholastic ability and other matters (hereafter, 2nd Selection) shall be 7,000 yen for the 1st Selection and 23,000 yen for the 2nd Selection, notwithstanding the stipulations of the preceding paragraph.

- (3) The stipulations in Paragraph 1 shall apply mutatis mutandis in cases where application for admission is based on stipulations set forth in Article 39, Paragraph 1.

Examination Fee:

Article 18-2. Notwithstanding the stipulations of the preceding article, a person with special circumstances may be exempt from paying the examination fee.

- (2) Notwithstanding the stipulations of the previous article, those whose home university (a university for which the students go through the admission procedure, and the same applies hereinafter) is Hiroshima University and apply for admission to the Joint International Master's Programme in Sustainable Development (Hiroshima University and University of Graz) of Graduate School of Humanities and Social Sciences or the Joint International Master's Programme in Sustainable Development (Hiroshima University and Leipzig University) of Graduate School of Advanced Science and Engineering may be exempt from paying the examination fee.

- (3) In addition to the stipulation in Paragraph 1, matters necessary to the exemption of the examination fee shall be separately prescribed.

Entrance Examination:

Article 19. An entrance examination shall be held for applicants for admission.

- (2) The entrance examination set forth in the preceding paragraph shall be separately prescribed.

Readmission:

Article 19-2. Notwithstanding the stipulations in the preceding article, This University may allow readmission of a person, following a screening process, who has withdrawn (except due to dismissal as disciplinary punishment) or been removed (except as stipulated in Article 43, Paragraph 2 of General Provisions which is applied to Article 42, Paragraph 1) from This Graduate School and is applying for readmission to the same graduate school, limited to within 5 years since the withdrawal or removal. However, if the graduate school, major, or basic organization for the delivery of inter-graduate school programs to which the person belonged at the time of withdrawal or removal has been reorganized and thus the person cannot apply for admission to the same graduate school, etc. to which the person belonged at the time of withdrawal or removal, the person may apply to a graduate school which will be designated through consultation between the relevant graduate schools.

- (2) Notwithstanding the stipulations in the preceding paragraph, this Graduate School may not allow admission due to the admission capacity, etc.
- (3) In the case of Paragraph 1 whereby a removed person passes the screening, the person shall complete the admission procedure as stipulated in Article 21 and pay the amount equivalent to the unpaid admission fee and tuition.
- (4) The approval of credits acquired prior to admission, term of study, and maximum period of enrollment for a person applying for admission based on Paragraph 1 shall be conducted by the dean of the graduate school, etc. following deliberations at the faculty meeting in the relevant graduate school, etc.

Selection of Successful Applicants:

Article 20. The president shall select the persons to be granted admission following Faculty Meeting deliberations in the Graduate Schools, etc.

Admission Procedure:

Article 21. A person intending to accept the offer of admission must submit the separately prescribed documents (hereafter, Admission Documents) and pay an admission fee of 282,000 yen by a designated date.

Admission Fee Exemption, Deferment of Collection, and Non-collection:

Article 22. Notwithstanding the stipulations of the preceding article, a person with special circumstances may be exempt from paying the entire or half of the admission fee, may defer collection thereof, or said person's tuition may be deemed non-collectable.

- (2) Notwithstanding the stipulations of the preceding article, a student receiving a scholarship through the separately prescribed Hiroshima University Phoenix Scholarship Program may be exempt from paying the entire admission fee.
- (3) Notwithstanding the stipulations in the previous article, a scholarship student in the separately prescribed Hiroshima University Hikarikagayaku Scholarship Program may be exempt from paying the entire admission.
- (4) Notwithstanding the stipulations of the previous article, of those students who study the Joint International Master's Programme in Sustainable Development (Hiroshima University and University of Graz) of Graduate School of Humanities and Social Sciences or the Joint International Master's Programme in Sustainable Development (Hiroshima University and Leipzig University) of Graduate School of Advanced Science and Engineering, those whose home university is Hiroshima University may be exempt from paying the entire admission fee.
- (5) Notwithstanding the stipulations of the previous article, a student who has demonstrated outstanding academic performance in the Second Term Doctorate Course of the Graduate School of Integrated Sciences for Life, Division of Integrated Sciences for Life

who is studying at the Vietnam Satellite Campus may be exempt from paying the entire admission fee.

- (6) In addition to the prescriptions set forth in Paragraphs 1 to 3, as well as Paragraph 5 in this article, matters necessary to the exemption, deferment, or non-collection of the admission fee shall be separately prescribed.

Offer of Admission:

Article 23. The president shall offer admission to persons who have completed the admission procedure set forth in Article 21 (including persons whose application for exemption from or, deferment of, the admission fee is pending).

Refund of the Examination Fee & Admission Fee:

Article 24. Examination fees and admission fees that have already been paid shall not be refunded.

- (2) Notwithstanding the stipulations of the preceding paragraph, when any of the following items apply, the fees stipulated in the applicable items shall be refunded at the request of the person who made the payment.

[1] In the entrance examination for the Division of Law School/Graduate School of Humanities and Social Sciences stipulated in Article 19, in cases where the 1st Selection takes place and a 2nd Selection occurs, 23,000 yen shall be refunded to a person who paid the examination fee but did not pass the 1st Selection.

[2] An amount equivalent to the examination fee shall be refunded when a person who paid the examination fee did not submit the Application Documents.

[3] An amount equivalent to the admission fee shall be refunded when a person who paid the admission fee did not submit the Admission Documents.

Chapter 3 Curricula

Organization of Curricula & Methods of Completion, etc.:

Article 25. The curricula of This Graduate School shall be organized systematically, establishing the class subjects necessary for achieving the education and research purposes.

- (2) The class subjects shall be divided into the class subjects that may be jointly completed by students of the Graduate Schools, etc. (hereinafter in the following paragraph shall be referred to as “Joint Subjects in Graduate Schools”) and the class subjects at the Graduate Schools, etc. at This Graduate School.
- (3) The matters necessary for the Joint Subjects in Graduate Schools shall be separately prescribed.
- (4) The class subjects and methods of completion at the Graduate Schools, etc. at This Graduate School shall be prescribed by the by-laws of the graduate schools or those of

the basic organizations for the delivery of inter-graduate school programs (hereinafter referred to as “By-laws of Graduate Schools, etc.”).

(5) In addition to the prescriptions of paragraph 2, of the class subjects at This Graduate School, class subjects that may be completed by students from all graduate schools (excluding the WISE Program prescribed in the following article or those that may be completed only by students who complete the Hiroshima University Graduate School Leader Education Program prescribed in Article 25-3) for the purpose of improving their skills shall be separately prescribed.

(6) Special programs shall be set up in This Graduate School for the purpose of cultivating human resources equipped with the capabilities for creating new values and leading the society through development of wider views and interest and sense of involvement in the society as well as accumulation of highly specialized knowledge in specific fields.

(7) Matters necessary to the special programs shall separately be determined.

Doctoral WISE Program (Program for World-leading Innovative and Smart Education):
Article 25-2. The WISE Program shall be established for the purpose of fostering doctoral students who can lead in the creation and application of new knowledge, create and shape value that leads the times, tackle social challenges and bring innovation to society.

(2) The matters necessary for the WISE Program shall be separately prescribed.

Hiroshima University Graduate School Leader Education Program:
Article 25-3. The Hiroshima University Graduate School Leader Education Program shall be established as a degree program that goes beyond the traditional frameworks of academic disciplines/research areas with the purpose of nurturing leaders equipped with the ability to creatively take up issues and perceive the nature of matters based on a broad foundation of knowledge.

(2) Matters necessary to the Hiroshima University Graduate School Leader Education Program shall be separately prescribed.

Class Methods & Standard for Calculating Credits:

Article 26. The stipulations set forth in Article 19-2 of the General Provisions and the stipulations set forth in Article 19-3 of the General Provisions shall apply mutatis mutandis regarding class methods at This Graduate School and regarding the standard for calculating credits, respectively.

Research Instruction:

Article 27. A student at This Graduate School (excluding students in a professional degree program) during the period of enrollment must complete class subjects prescribed for in the by-laws of the Graduate Schools, etc., acquire enough credits necessary for completion, and receive instruction for the creation of a dissertation, etc. (hereafter, Research Instruction). However, this shall not apply to a person recognized as having

academic ability equal to, or greater than, a person possessing a master's degree or professional degree in terms of qualifications for admission to graduate school in accordance with stipulations set forth in Item 2 to Item 8 of Article 16, in regard to the acquisition of credits and completion of class subjects in cases where s/he is admitted to a Second Term Doctorate Course.

- (2) When deemed educationally beneficial, the Graduate Schools, etc. may approve of a student (excluding students in a professional degree program) studying abroad at another graduate school or research institute, etc., or at a foreign graduate school without taking a leave of absence to receive the required Research Instruction (except that which is received by a student in a division of one of the Joint International Programmes stipulated in Paragraph 2 of Article 55 in the graduate school where s/he majors in the said division of the Joint International Programme, and the same applies hereinafter), following discussions in advance with said graduate school or research institute, or said foreign graduate school, etc. However, the period of said Research Instruction shall not exceed 1 year in cases of approval for students in the master's course and First Term Doctorate Course.

Special Cases of Educational Methods:

Article 28. In cases where deemed a special educational requirement, education may be carried out in a suitable manner such as by conducting classes or Research Instruction, etc. in the evening or at another specified time or period in courses at This Graduate School.

Granting of Credits:

Article 29. The stipulations set forth in Article 19-4 of the General Provisions regarding granting of credits shall apply mutatis mutandis. In this case, "and attendance" shall be changed to "or research paper."

Performance Assessment of Class Subjects:

Article 30. The assessment of performance in a class subject shall utilize the 5 levels of excellent, superior, good, fair, and poor. Excellent, superior, good, and fair shall be passing grades, while poor shall be a failing grade.

Maximum Course Registration:

Article 31. In regard to the number of credits a student must acquire as a requirement for graduation, the maximum number of credits a student may register for in 1 year or one semester shall be as prescribed by the Graduate School of Humanities and Social Sciences, so that a student in a professional degree program completes an appropriate number of class subjects over each year.

Article 31-2. In regard to the number of credits a student must acquire as a requirement for graduation, the Graduate Schools, etc. shall prescribe the maximum number of credits a

student may register for 1 year or one semester, so that a student in the First Term Doctorate Course completes an appropriate number of class subjects over each year.

- (2) The Graduate Schools, etc. may allow a First Term Doctorate Course student who has completed the prescribed credits with high marks to register for courses that exceed the maximum number of credits in the next semester.

Long-term Completion of Curricula:

Article 32. When a student expresses the intent to systematically complete the curricula and complete a course over a certain period of time that exceeds the standard term of study due to circumstances such as having an occupation, that systematic completion (hereafter, Long-term Completion of Curricula) may be approved provided it does not present a hindrance to the said Graduate Schools, etc.

- (2) Matters necessary to the handling of Long-term Completion of Curricula shall be separately prescribed.

Acquiring Necessary Qualifications for the Granting of Teaching Credentials:

Article 33. The stipulations set forth in Article 24 of the General Provisions regarding the acquisition of necessary qualifications for the granting of teaching credentials shall apply *mutatis mutandis*.

Organizational Training, etc. to Improve Educational Content, etc.:

Article 34. This Graduate School shall implement organizational training and research for the purpose of improving the class content and methods of classes and Research Instruction.

Student Exchange and Studying Abroad, etc.:

Article 35. When deemed educationally beneficial, Graduate Schools, etc. may regard the number of credits acquired for class subjects completed in an educational course at another graduate school (including a foreign graduate school and the United Nations University) as having been acquired by completion of class subjects at This Graduate School, provided it does not exceed 15 credits (For the Division of Professional Development for Teachers and School Leaders/Graduate School of Humanities and Social Sciences, the amount shall not exceed one half of the prescribed number of credits required to complete the program. 30 credits for the Division of Law School/Graduate School of Humanities and Social Sciences; however, in cases where the acquisition of over 93 credits is required for completion of the Division of Law School/Graduate School of Humanities and Social Sciences, it may be regarded as having acquired over 30 credits, limited to the number of credits in excess), following deliberations of the Faculty Meeting in the said Graduate Schools, etc.

- (2) The stipulations set forth in the preceding paragraph shall apply *mutatis mutandis* in cases where a student (except those in the Division of Professional Development for

Teachers and School Leaders/Graduate School of Humanities and Social Sciences) completes class subjects conducted by a foreign school by correspondence education in Japan.

(3) The number of credits that may be regarded as having been acquired in accordance with the stipulations set forth in the preceding 2 paragraphs shall not exceed 15 credits in total For the Division of Professional Development for Teachers and School Leaders/Graduate School of Humanities and Social Sciences, the amount shall not exceed one half of the prescribed number of credits required to complete the program. 30 credits shall not be exceeded for the Division of Law School/Graduate School of Humanities and Social Sciences (excluding the number of credits regarded as having been acquired that exceed 30 credits, in accordance with the stipulations set forth in the proviso to Paragraph 1).

(4) Matters necessary to student exchange and studying abroad shall be separately stipulated.

Approval of Credits Acquired Prior to Admission:

Article 36. When deemed educationally beneficial, Graduate Schools, etc. may regard credits (including credits acquired as a credited auditor) acquired by completing class subjects in a curricula at a graduate school (including a foreign graduate school and the United Nations University) prior to being admitted to This Graduate School as credits acquired by completing class subjects at This Graduate School.

(2) The number of credits that may be regarded as completed in accordance with the stipulations set forth in the preceding paragraph, in regard to credits other than those acquired at This Graduate school (including credits acquired as a credited auditor) and excluding the case of school transfer, shall not exceed 15 credits (For the Division of Professional Development for Teachers and School Leaders/Graduate School of Humanities and Social Sciences, the amount shall not exceed one half of the prescribed number of credits required to complete the program, which includes the number of credits that may be regarded as having been acquired in accordance with stipulations set forth in Paragraph 1 of the preceding Article, and Article 44, Paragraph 2. 30 credits for the Division of Law School/Graduate School of Humanities and Social Sciences together with the number of credits that may be regarded as having been acquired in accordance with stipulations set forth in Paragraph 1 and Paragraph 2 of the preceding Article (excluding the number of credits regarded as having been acquired that exceed 30 credits, in accordance with the stipulations set forth in the proviso to Paragraph 1 of the preceding Article. (However, with regard to the number of credits acquired by those students who enter the Division of Law School/Graduate School of Humanities and Social Sciences after completing a recognized cooperative legal profession basic course

(including a course of a university in the recognized legal profession training cooperative agreement only with a graduate law school except the Division of Law School/Graduate School of Humanities and Social Sciences, and the same applies to Article 45, Paragraph 4) or those students who are confirmed to have the learning equal to the said students by the Graduate School of Humanities and Social Sciences in the courses completed in a recognized graduate law school except the Division of Law School/Graduate School of Humanities and Social Sciences, it shall be 46 together with the credits recognized to have been completed pursuant to the stipulations of Paragraphs 1 and 2 of the preceding Article (except the credits that exceed 30 as provided in the proviso to Paragraph 1 of the preceding Article).)

- (3) Based on the stipulations in the previous Article and preceding paragraphs, the number of credits that may be regarded as acquired in This Graduate School (except the Division of Professional Development for Teachers and School Leaders and Division of Law School/Graduate School of Humanities and Social Sciences) shall not exceed 20 in total.
- (4) Matters necessary to the approval of credits acquired prior to admission in accordance with the stipulations set forth in the preceding three paragraphs shall be separately stipulated.

Chapter 4 Leave of Absence, Withdrawal & Transfer

Leave of Absence:

Article 37. The stipulations set forth in Article 32 to Article 34 of the General Provisions regarding leave of absence shall apply *mutatis mutandis*.

Withdrawal:

Article 38. The stipulations set forth in Article 35 of the General Provisions regarding withdrawal shall apply *mutatis mutandis*.

Transfer:

Article 39. A student applying for transfer from a course at another graduate school or the United Nations University shall obtain permission following an entrance exam, restricted to the start of each semester.

- (2) When a student at This Graduate School intends to apply for transfer to another graduate school, s/he must carry out a predetermined procedure and submit a petition.

Chapter 5 Reward and Punishment & Removal from Register

Reward:

Article 40. The stipulations set forth in Article 39 of the General Provisions regarding rewards shall apply *mutatis mutandis*.

Punishment:

Article 41. The stipulations set forth in Article 40 to Article 42 of the General Provisions regarding punishment shall apply *mutatis mutandis*.

Removal from Register:

Article 42. The stipulations set forth in Article 43 of the General Provisions regarding removal from register shall apply mutatis mutandis.

(2) When a student in the Division of Law School/Graduate School of Humanities and Social Sciences fails to advance to the next grade within 2 years (or, in the case of the 3rd year of the curriculum, fails to complete the course within 2 years), the President may, following deliberations in the Faculty Meeting of the said Graduate School, remove the student.

Chapter 6 Course Completion & Conferment of Degrees

Completion Requirements:

Article 43. The completion requirements for a master's course and First Term Doctorate Course shall be enrollment in a graduate school for at least 2 years (Graduate Schools, etc., majors or a student's division of studies that prescribe a standard term of study of over 2 years shall be the said standard term of study), acquisition of 30 or more credits, and following the receiving of required Research Instruction, the passing of a final examination and screening for a master's thesis submitted during the enrollment period. However, an enrollment period of 1 year or more in graduate school shall be regarded as sufficient for a student recognized by the dean of the Graduate Schools, etc., following deliberations in the Faculty Meeting in the said Graduate Schools, etc. as having demonstrated outstanding achievement.

(2) In the case of the preceding paragraph, when the dean of the Graduate Schools, etc., following deliberations in said Faculty Meeting in the Graduate Schools, etc. recognizes it as appropriate in accordance with the aims of that master's course or First Term Doctorate Course, a screening of research outcomes on a particular topic may be substituted for a master's thesis screening.

(3) In cases where it is deemed necessary for the purpose of achieving the aims of a First Term Doctorate Course, in place of the screening of a master's thesis or research outcomes on a particular topic and passing of the examination stipulated in the preceding two paragraphs, completion may be accomplished by passing the following examination and screening carried out by the said Graduate Schools, etc.

[1] An examination on advanced specialized knowledge and capabilities in a major field of study and fundamental grounding in areas related to said major field of study that are mastered and should be cultivated in said First Term Doctorate Course

[2] Screening on matters that should be acquired in the aforementioned First Term Doctorate Course regarding abilities necessary to independently execute research related to a dissertation

Article 44. The completion requirements for a doctorate course shall be enrollment in a graduate school for at least 5 years (for a person enrolled in a master's course (excluding a master's course with a standard term of study of over 1 year but less than 2 years; the same applies hereinafter in this paragraph) for at least 2 years (or, in the case of a graduate school, department, or student course classification that sets a standard term of study that exceeds 2 years, such a standard term of study; the same applies hereinafter in the main text of this Article) who has completed said course, the 2 years of enrollment in said course shall be included; 4 years for the Division of Biomedical Sciences/Graduate School of Biomedical and Health Sciences), acquisition of 30 or more credits, and following the receiving of required Research Instruction, the passing of a final examination and screening for a submitted dissertation. However, for a student recognized by the dean of the Graduate Schools, etc., following deliberations in the Faculty Meeting in the said Graduate Schools, etc. as having demonstrated outstanding achievement, an enrollment period of at least 3 years (for a student in a doctorate course other than the Division of Biomedical Sciences/Graduate School of Biomedical and Health Sciences who has been enrolled in a master's course for at least 2 years and has completed said course, an enrollment period of 2 years in said course shall be included) in a graduate school shall be regarded as sufficient.

(2) The completion requirements for a doctorate course (except the Division of Biomedical Sciences/Graduate School of Biomedical and Health Sciences) for a person who has completed a master's course where the standard term of study is of 1 year to 2 years, or a person who completed a master's course during the enrollment period in accordance with the stipulations set forth in the proviso for Paragraph 1 under Article 16 of the Standards for the Establishment of Graduate Schools, are enrollment for a period of 3 years or longer in addition to the enrollment period in a master's course at a graduate school, acquisition of 30 or more credits, and following the reception of required Research Instruction, the passing of a final examination and screening for a submitted dissertation. However, an enrollment period of at least 3 years in a graduate school (including a period of over 1 year but less than 2 years for a person who has completed a master's course with a standard term of study of over 1 year but less than 2 years or the period of enrollment (up to 2 years) in a master's course for a person who has completed the course pursuant to the proviso for Paragraph 1 under Article 16 of the Standards for the Establishment of Graduate Schools) shall be regarded as sufficient for a person recognized by the dean of the Graduate Schools, etc., following deliberations in the Faculty Meeting in the said Graduate Schools, etc. as having demonstrated outstanding research achievements.

(3) Notwithstanding the stipulations of the preceding two paragraphs, for a person holding a master's degree or professional degree or recognized as having academic abilities equal to, or greater than, a person possessing a master's degree or professional degree in relation to qualifications for admission to a graduate school in accordance with stipulations set forth in Item 2 to Item 8 of Article 16, the completion requirements for a doctorate course in cases of admittance to a Second Term Doctorate course shall be enrollment of at least 3 years in a graduate school (except professional graduate schools; the same applies hereinafter in this paragraph), the acquisition of credits when prescriptions in the said Graduate Schools, etc. exist, and following the reception of required Research Instruction, the passing of a final examination and screening for a submitted dissertation. However, an enrollment period of at least 1 year in a graduate school (for a person who has completed a master's course with a standard term of study of over 1 year but less than 2 years and a person who has completed a professional degree course with a standard term of study of over 1 year but less than 2 years, the period shall be 3 years minus the period of study in that course, and for a person who has completed a master's course with a period of enrollment as set forth in the proviso of Paragraph 1 under Article 16 of the Standards for the Establishment of Graduate Schools, the period shall be 3 years minus the period of study in that course (up to 2 years) shall be regarded as sufficient for a person recognized by the dean of the Graduate Schools, etc., following deliberations in the Faculty Meeting in the said Graduate Schools, etc. as having demonstrated outstanding research achievements.

Article 44-2. The completion requirements for the Division of Professional Development for Teachers and School Leaders/Graduate School of Humanities and Social Sciences shall be enrollment for at least 2 years and an acquisition of at least such number of credits as specified by the Graduate School of Humanities and Social Sciences, but 45 or more credits (including at least 10 credits of student teaching at an elementary school ("Elementary School" is stipulated in Paragraph 1 of Article 26 of the Standards for the Establishment of Professional Graduate Schools (Ordinance of the Ministry of Education, Culture, Sports, Science and Technology No. 16 of March 31, 2003); hereafter, the same shall apply), for the purpose of producing highly qualified teachers with advanced professional abilities and practical skills or other educational institution.

(2) When deemed educationally beneficial, a person with experience working as an Elementary School teacher before enrolling in this program may be granted exemption, in part or in full, from acquiring credits for student teaching stipulated in the preceding paragraph, provided it does not exceed 10 credits.

(3) Notwithstanding the stipulations of Paragraph 1, when a person has acquired credits prior to enrolling in this program in accordance with the stipulations in Article 36,

Paragraph 1 and those credits have been deemed as having been acquired in this program, and said person has been recognized as having completed part of the curriculum by acquiring said credits, said person may be deemed as having been enrolled in this program for a period specified by the Graduate School of Humanities and Social Sciences, provided it does not exceed 1 year, taking into consideration factors such as the number of credits in question and the time it took to acquire said credits. However, even in this case, said person must be enrolled in this program for at least 1 year.

Article 45. The completion requirements for the Division of Law School/Graduate School of Humanities and Social Sciences shall be enrollment of at least 3 years and the acquisition of a number of credits greater than that prescribed by the Graduate School of Humanities and Social Sciences of at least 93 credits. However, an enrollment period for a person recognized as having acquired credits (limited to those credits acquired after becoming eligible for admission pursuant to the stipulations in Law Article 102, Paragraph 1) prior to admission may be abbreviated by a period equal to the number of said credits, provided it does not exceed 1 year.

- (2) Notwithstanding the stipulations of the preceding paragraph, a person recognized as having the fundamental knowledge of legal studies deemed necessary in the Division of Law School/Graduate School of Humanities and Social Sciences (hereafter, Legal Studies Student) shall be regarded as having acquired credits within a range that does not exceed 30 credits, and may abbreviate the enrollment period by a period equal to the number of said credits, provided it does not exceed 1 year. However, in cases where acquisition of over 93 credits is required for completion, it may be regarded as having acquired over 30 credits, limited to the number of credits in excess.
- (3) The number of credits that may be regarded as having been acquired by a Legal Studies Student in accordance with the stipulations set forth in the preceding paragraph (except those credits deemed to exceed 30 credits pursuant to the stipulations in the proviso to the preceding paragraph) shall not exceed 30 credits (excluding the number of credits regarded as having been acquired that exceed 30 credits, in accordance with the stipulations set forth in the proviso to Article 35, Paragraph 1) together with the number of credits that may be regarded as having been acquired in accordance with the stipulations set forth in Paragraph 1 and Paragraph 2 of Article 35, and Article 36, Paragraph 1.
- (4) With regard to the application of Paragraphs 2 and 3 to the students who enter the Division of Law School/Graduate School of Humanities and Social Sciences after completing a recognized cooperative legal profession basic course or those students recognized to have learning equal to the said students by the Graduate School of Humanities and Social Sciences, “30 credits” in Paragraph 2 shall be “46 credits”, and

“30 credits pursuant to the stipulations in the proviso to the preceding paragraph” in Paragraph 3 shall be “46 credits pursuant to the stipulations in the proviso to the preceding paragraph,” while “30 credits... together with” shall be “46 credits... together with,” respectively.

Shortening of Enrollment Period in the Graduate School:

Article 45-2. In case Graduate Schools, etc. regard, pursuant to Paragraph 1 of Article 36, credits acquired by a student before being admitted to This Graduate School (limited to those credits acquired after being qualified to be admitted pursuant to Paragraph 1 of Article 102 of the Law) as acquired by completing class subjects in a curriculum at a graduate school and thereby the student as having completed part of the curricula of Master’s Course or Doctorate Course (except Second Term Doctorate Course) of This Graduate School, the student may be regarded as having been enrolled for a period up to one year decided by the Graduate Schools, etc. in consideration for the number of credits and time required for the acquisition thereof. However, even in this case, regarding the Master’s Course, said person must be enrolled in this Course for at least 1 year.

(2) The stipulations in the preceding paragraph shall not apply to the enrollment period of the Doctorate Course stipulated in Paragraphs 1 and 2 of Article 44 (except the period of enrollment in the Master’s Course, which is included in the period of enrollment in the Doctorate Course pursuant to the stipulations of Paragraphs 1 and 2 of the same Article) for those who have completed the Master’s Course.

Conferment of Degrees:

Article 46. A person who completes This Graduate School shall be conferred a master’s degree, doctorate degree, or professional degree by the president.

(2) A doctorate degree shall be conferred even upon a person who does not undertake a doctorate course at This Graduate School when such a person submits a dissertation and passes screening, and an interview.

(3) Matters necessary to the conferment of a master’s, doctorate, or professional degree shall be separately stipulated.

Dissertations and Final Examinations:

Article 47. The final examination set forth in Article 43 and Article 44 shall focus on a dissertation and cover related subjects.

Article 48. The passing or failure of a dissertation and final examination shall be determined by the dean of the Graduate Schools, etc. following screening at the Faculty Meeting in the said Graduate Schools, etc.

(2) The method of the screening verdict shall be prescribed by the Graduate Schools, etc.

Chapter 7 Tuition

Tuition:

Article 49. Annual tuition shall be 535,800 yen (804,000 yen for the Division of Law School/Graduate School of Humanities and Social Sciences). However, the amount for a person approved for Long-term Completion of Curricula in accordance with Article 32 shall be calculated by dividing the amount obtained by multiplying the annual tuition amount by the number of years equal to the remaining standard term of study at the time the Long-term Completion of Curricula was approved, by the number of years of said Long-term Completion of Curricula (when that amount contains a fraction less than 10 yen, the amount shall be rounded up).

- (2) The entire tuition for the second semester may be exempt for students demonstrating outstanding achievement.
- (3) When a person who has paid the tuition becomes exempt from paying tuition as a student demonstrating outstanding achievement, an amount equal to the tuition for the second semester shall be refunded in accordance with the request of the person who made the payment.
- (4) In addition to the prescriptions in Paragraph 2, a scholarship student in the separately prescribed Hiroshima University Hikorikagayaku Scholarship Program may be exempt from paying the entire tuition.
- (5) In addition to Paragraphs 2 and preceding two paragraphs, a full tuition shall be exempted from the students of the Joint International Master's Programme in Sustainable Development (Hiroshima University and University of Graz) of Graduate School of Humanities and Social Sciences or the Joint International Master's Programme in Sustainable Development (Hiroshima University and Leipzig University) of Graduate School of Advanced Science and Engineering, who make Hiroshima University his or her home university and have demonstrated outstanding academic performance in the corresponding term.
- (6) In addition to Paragraphs 2 and preceding two paragraphs, a full tuition of each term shall be exempted from a student who has demonstrated outstanding academic performance in the Second Term Doctorate Course of the Graduate School of Integrated Sciences for Life, Division of Integrated Sciences for Life who is studying at the Vietnam Satellite Campus.
- (7) In addition to the prescriptions in the preceding paragraphs, the stipulations set forth in Article 47, Paragraph 2 to Article 51 of the General Provisions regarding payment procedures, etc. for tuition shall apply *mutatis mutandis*.

Chapter 8 Special Research Students

Special Research Students:

Article 50. When a person applies to receive Research Instruction at This Graduate School who is a student at another graduate school, foreign graduate school, etc., or the United

Nations University, Graduate Schools, etc. may accept him/her as a special research student, based on discussions with said other graduate school, foreign graduate school, etc., or the United Nations University.

Tuition , etc. for Special Research Students:

Article 51. The tuition for special research students shall be an amount equal to the amount stipulated in Article 8 of the Hiroshima University Research Student Regulations (April 1, 2004 Regulation No. 10). However, tuition shall not be collected from a graduate school student from a national university or a person who falls under any of the items below.

[1] When the tuition for said student is deemed mutually non-collectible through an inter-university exchange agreement for special research students that is concluded with a public or private university

[2] When the tuition for said student is deemed mutually non-collectible through a university exchange agreement, faculty exchange agreement, or the equivalent that is concluded with a foreign graduate school, etc.

(2) Special research students must pay the amount stipulated in the preceding paragraph by a designated date every 6 months (when the period of intended Research Instruction is less than 6 months, tuition must be paid for that period), in accordance with the period of intended Research Instruction.

(3) Tuition that has already been paid shall not be refunded.

(4) Examination fees and admission fees related to special research students shall not be collected.

Application of Regulations:

Article 52. In addition to the prescriptions set forth in this Chapter, the regulations regarding students at This Graduate School shall apply mutatis mutandis to special research students.

Chapter 9 Research Students and Credited Auditors, etc.

Research Students:

Article 53. When a person other than a student at This Graduate School applies to research a specific matter at This Graduate School, s/he may be granted admission as a research student by selection, provided it does not present a hindrance to education and research.

(2) Matters necessary to research students shall be separately stipulated.

Credited Auditors:

Article 54. When a person who is not a student at This Graduate School applies to complete one or more class subjects at This Graduate School, admission as a credited auditor may be granted by selection, provided it does not present a hindrance to education and research.

(2) Matters necessary to credited auditors shall be separately prescribed.

Short-term International Exchange Students:

Article 54-2. When a student in a university, etc. in a foreign country applies to attend seminars provided by This Graduate School as part of the curricula of the university, etc. in a foreign country, s/he may be admitted as a short-term international exchange student upon screening, provided it does not present a hindrance to education and research.

(2) A university, etc. in a foreign country is as follows:

[1] A university or college (including higher education institution other than university) in a foreign country

[2] An educational institution designated by the educational system of a foreign country as offering a curriculum of a university or college in that country, which is separately designated by the Minister of Education, Culture, Sports, Science and Technology

[3] The United Nations University (established based on the December 11, 1972 United Nations General Assembly resolution stipulated in Article 1, Paragraph 2 of the Act on Special Measures (Act No. 72 of 1976) incidental to enforcement of the agreement between the United Nations and Japan regarding the headquarters of the United Nations University)

(3) Particulars regarding the short-term international exchange students shall be provided separately.

Law School Research Students:

Article 54-3. When a person who has completed the Division of Law School/Graduate School of Humanities and Social Sciences applies to conduct self-learning at the Division of Law School/Graduate School of Humanities and Social Sciences following completion, s/he may be accepted as a law school research student, provided it does not present a hindrance to education and research.

(2) Matters necessary to law school research students shall be prescribed by the Graduate School of Humanities and Social Sciences.

Credit Program:

Article 54-4. A credit program may be established at This Graduate School as a special course as stipulated in Article 105 of the Law for the purpose of utilizing the education and research resources at This Graduate School to actively provide learning opportunities for adults in the workforce, etc.

(2) Matters necessary to the credit program shall be separately prescribed.

Chapter 10 Teacher Organization

Teacher Organization:

Article 55. Professors or associate professors shall be in charge of classes in Graduate Schools, etc. However, when necessary, instructors or assistant professors shall be in charge or share duties.

(2) Professors shall be in charge of Research Instruction in Graduate Schools, etc. However, when necessary, associate professors, instructors, or assistant professors shall be in charge or share duties.

(3) Professors shall be in charge of classes in the Division of Law School/Graduate School of Humanities and Social Sciences. However, when necessary, associate professors, instructors, or assistant professors shall be in charge or share duties.

Chapter 11 Divisions of Joint International Programme

Curricula of Joint International Programme:

Article 55-2. The joint curricula with foreign graduate schools in cooperation (those graduate schools in foreign countries implementing education and research in cooperation with the graduate schools having divisions of joint international programme, and the same applies hereinafter) (hereinafter, "Curricula of Joint International Programme") shall be provided in the graduate school by-laws.

Approval of credits regarding the Curricula of Joint International Programme:

Article 55-3. The graduate schools having a division of joint international programme shall regard the credits a student has acquired for class subjects in a curriculum of joint international programme in a foreign graduate school in cooperation as those acquired by completing the class subjects in the Curricula of Joint International Programme.

(2) The graduate schools having a division of joint international programme shall regard Research Instruction a student has received in a curriculum of joint international programme in a foreign graduate school in cooperation as such in the Curricula of Joint International Programme.

Completion Requirements for the Divisions of Joint International Programmes

Article 55-4. With regard to the requirements for completing the Master's Course in the Curricula of Joint International Programme, in addition to the stipulations in Paragraphs 1 and 2 of Article 43, a student shall acquire at least 10 credits by completing the class subjects in the Curricula of Joint International Programme at a foreign graduate school in cooperation and a graduate school having a division of joint international programme.

(2) With regard to the credits acquired by completing the class subjects in the Curricula of Joint International Programme in the graduate school having a division of joint international programme and any of the foreign graduate schools in cooperation based on the previous paragraph, they may be or may not be regarded as acquired pursuant to the stipulations in Articles 35 and 36 or Paragraph 1 of the previous article. However, with regard to the credits which are regarded to have been acquired pursuant to Article

36, the preceding sentence shall not apply to the case when it is deemed necessary for organizing and implementing the Curricula of Joint International Programme.

Tuition, etc. of Students in Divisions of Joint International Programme:

Article 55-5. Of those students in the divisions of joint international programme, a student whose home university is a foreign graduate school in cooperation shall not be required to pay the examination fee, admission fee, or tuition of This University regardless of the stipulations in Paragraph 1 of Article 18, Article 21, or Paragraph 1 of Article 49.

Other:

Article 55-6. With regard to the matters listed below concerning the divisions of joint international programme shall be decided upon discussion with the foreign graduate schools in cooperation:

- [1] Matters related to organization of the curricula
- [2] Matters related to educational organization
- [3] Matters related to selection of entrants and conferment of degrees
- [4] Matters related to management and safety during the enrollment of students
- [5] Matters related to scholarship and welfare/guidance of students
- [6] Matters related to evaluation of education/research activities
- [7] Other matters related to the divisions of joint international programme

Chapter 12 Miscellaneous Provisions

Miscellaneous Provisions:

Article 56. The dean of Graduate Schools, etc. shall report revisions to the by-laws of the Graduate Schools, etc. to the president.

(2) In addition to the regulations prescribed here, the stipulations set forth in the General Provisions shall apply mutatis mutandis to matters necessary to student learning at This Graduate School.

Article 57. In cases where the General Provisions are applied mutatis mutandis to these regulations, “school dean” shall be replaced with “dean of Graduate Schools, etc.”

1. This regulation shall come into effect from March 11, 2024, and the regulation of the revised Hiroshima University Graduate School Regulations (hereinafter, “New Provisions”) following the aforementioned regulation shall come into effect from October 1, 2023.
2. The stipulations regarding the tuition exemption of the students of the Joint International Master’s Programme in Sustainable Development (Hiroshima University and University of Graz) of Graduate School of Humanities and Social Sciences or the Joint International Master’s Programme in Sustainable Development (Hiroshima University and Leipzig University) of Graduate School of Advanced Science and Engineering, who entered the school in 2022 or before and make Hiroshima University his or her home university shall remain as applicable, regardless of stipulations set forth in Article 49 of the New Provisions.

Supplementary Provisions (July 16, 2024 Regulation No. 109)

This regulation shall come into effect from July 16, 2024, and stipulations set forth in the Hiroshima University Graduate School Regulations revised in accordance with this regulation shall be applied from April 1, 2024.

Supplementary Provisions (February 18, 2025, Regulation No. 13)

This regulation shall come into effect from February 18, 2025, and stipulations set forth in the Hiroshima University Graduate School Regulations revised in accordance with this regulation shall be applied from October 1, 2024.

Supplementary Provisions (March 28, 2025, Regulation No. 41)

- 1 This regulation shall come into effect from April 1, 2025.
- 2 The admission capacity for the First Term Doctorate Course of the Graduate School of Advanced Science and Engineering and the admission capacity of the entire School for FY2025 shall be as shown in the following table, regardless of stipulations set forth in the Appended Table for the Hiroshima University Graduate School Regulations revised in accordance with this regulation.
