Hiroshima University Regulations Regarding Student Commendation

Purpose:

Article 1. These Regulations prescribe matters necessary to the commendation of students at Hiroshima University (hereafter, This University), based on stipulations in Article 39, Paragraph 2 of Hiroshima University General Provisions (April 1, 2004 Regulation No. 2) (including cases where Article 40 of Hiroshima University Graduate School Regulations (January 15, 2008 Regulation No. 2) and Article 16, Paragraph 1 of Hiroshima University Special Needs Education: Regulations for the Program in Special Education (March 20, 2007 Regulation No. 44) are applied mutatis mutandis).

Standards of Commendation:

Article 2. A commendation shall be given to a student or organization consisting of student members at This University that falls under one of the following.

- [1] A person recognized as having demonstrated particularly remarkable performance in academic studies
- [2] A person recognized as having achieved particularly outstanding performance in extracurricular activities and played a role in the promotion of extracurricular activities
- [3] A person recognized as having demonstrated particularly remarkable performance in social activities and received societal acclaim
- [4] A person recognized as having demonstrated other kinds of behavior, etc. deserving of commendation that is equal to or greater than the preceding 3 items

Recommendation for Commendation:

Article 3. When there is an individual recognized in accordance with one of the items in the preceding article, the executive vice president (Education and Peacebuilding), vice president (Student Support/Diversity and Inclusion), school dean, graduate school dean, and the dean of the basic organizations for the delivery of inter-graduate school programs may recommend him/her to the president for commendation.

Deliberations on Commendation:

Article 4. When the recommendation set forth in the preceding article is received, the president shall establish a review board.

- (2) The members that make up the review board shall be separately prescribed.
- (3) A commendation shall be granted after the opinions of the review board are heard and deliberations are held by the Education and Research Council.

Method of Commendation:

Article 5. The president shall award a certificate of commendation.

Period of Commendation:

Article 6. As a rule, commendations shall be granted on the following days.

The day of the entrance ceremony

The day diplomas are presented

(2) Notwithstanding the stipulations set forth in the preceding paragraph, commendations shall be granted when deemed necessary.

Official Announcement:

Article 7. Commendation recipients shall be officially announced inside and outside the university.

Administrative Affairs:

Article 8. Administrative affairs related to student commendation shall be processed by the General Student Support Center.

Miscellaneous Provisions:

Article 9. In addition to the regulations prescribed here, matters necessary to student commendation shall be separately prescribed.

Supplementary Provisions

This regulation shall come into effect from April 1, 2004.
