Chapter 1 General Provisions

Purpose:

Article 1. The General Provisions prescribe matters necessary to students' learning at schools at Hiroshima University (hereafter, This University), based on stipulations in Article 18 of Hiroshima University Regulations (April 1, 2004 Regulation No. 1).

Departments, Clusters, and Courses:

Article 2. The following department of study shall be established at the schools of This University.

(2) The School of Law and School of Economics shall have a day/evening course system, and establish a course that conducts classes during the day (hereafter, Day Course) and a course that primarily conducts classes in the evening (hereafter, Evening Course).

Purpose of Education and Research:

Article 2-2. The schools shall be founded on the principles of This University and clearly state their inherent educational objectives respectively. Each school shall aim to cultivate highly adaptable human resources that combine fundamental skills and applied skills

through education and research implemented for the purpose of achieving those objectives.

- (2) The education and research aims for each school, department, cluster of study, etc. shall be prescribed in the by-laws of each school.

Admission Capacity:

Article 3. The admission capacity for This University shall be as shown in the Appended Table.

Term of Study:

Article 4. The term of study for This University shall be 4 years. However, it shall be 6 years for the School of Medicine/Medicine, the School of Dentistry/Dentistry, and the School of Pharmaceutical Sciences/Pharmaceutical Sciences.

Article 5. In cases where a person who has acquired a certain number of credits enters This University as a credited auditor pursuant to Article 52-2, when it has been deemed that a portion of the curricula at the relevant school has been completed through the acquisition of said credits, a period of time specified by the school may be included in the term of study in consideration of the acquired number of credits and other matters. However, that period shall not exceed 1/2 of said school's term of study.

Maximum Period of Enrollment:

Article 6. The maximum period of enrollment for schools at This University shall be 8 years (excluding the School of Medicine/Medicine, the School of Dentistry/Dentistry, the School of Pharmaceutical Sciences/Pharmaceutical Sciences, and the School of Engineering).

- (2) The maximum period of enrollment for the School of Medicine/Medicine, the School of Dentistry/Dentistry, and the School of Pharmaceutical Sciences/Pharmaceutical Sciences shall be 12 years.

- (3) The maximum period of enrollment for the School of Engineering shall be 6 years.

Academic Year:

Article 7. The academic year shall begin on April 1<sup>st</sup> and end on March 31<sup>st</sup> of the following year.

Academic Term:

Article 8. The academic year shall be divided into 2 terms, the first semester and second semester. The first semester shall be from April 1<sup>st</sup> to September 30<sup>th</sup>, and the second semester shall be from October 1<sup>st</sup> to March 31<sup>st</sup> of the following year.

- (2) Each semester stipulated in the preceding paragraph may be divided into a first half and second half.

(3) The first half of the first semester shall be the first term, and the second half shall be the second term; the first half of the second semester shall be the third term, and the second half shall be the fourth term.

#### University Holidays:

Article 9. Regular holidays during the academic year shall be as follows.

- [1] Saturdays and Sundays
- [2] Holidays stipulated in the Act on National Holidays (Act No. 178 of 1948)
- [3] Spring Holiday: April 1<sup>st</sup> to April 7<sup>th</sup>
- [4] Summer Holiday: August 11<sup>th</sup> to September 30<sup>th</sup>
- [5] Winter Holiday: December 26<sup>th</sup> to January 5<sup>th</sup> of the following year

(2) The president may change the university holidays specified in Item 3 to Item 5 of the preceding paragraph when special circumstances exist.

(3) Special university holidays shall be prescribed on a case-by-case basis.

(4) When special circumstances exist, classes may be held on the university holidays prescribed in the preceding 3 paragraphs.

#### Chapter 2 Admission

##### Admission Period:

Article 10. The admission period shall be at the start of the academic year.

(2) Notwithstanding the stipulations of the preceding paragraph, admission may occur at the start of a semester.

##### Admission Qualifications:

Article 11. A person that falls under any of the following items shall be eligible for admission to This University.

- [1] A person who has graduated from a high school or secondary school
- [2] A person who has completed 12 years of school education in a general course, or a person who has completed school education equivalent thereto through a course other than the general course
- [3] A person who has completed 12 years of school education in a foreign country, or a person who has an equivalent qualification designated by the Minister of Education, Culture, Sports, Science and Technology
- [4] A person who has completed an advanced course at a vocational school (restricted to a term of study of at least 3 years and the fulfillment of other standards prescribed by the Minister of Education, Culture, Sports, Science and Technology) that has been separately designated by the Minister, provided the completion occurred after a date prescribed by the Minister

- [5] A person who has completed a relevant course of study at an educational facility in a foreign country certified by the Minister of Education, Culture, Sports, Science and Technology as having a curricula equivalent to high school curricula
- [6] A person designated by the Minister of Education, Culture, Sports, Science and Technology
- [7] A person who has passed the Upper Secondary School Equivalency Examination under the Regulations on the Upper Secondary School Equivalency Examination (Ordinance of the Ministry of Education, Culture, Sports, Science and Technology No. 1 of 2005; including a person who has passed the University Admission Qualifying Examination under the Regulations on the University Admission Qualifying Examination (Ordinance of the Ministry of Education No. 13 of 1951) before their abolishment in accordance with the stipulations in Article 2 of supplementary provisions to the Regulations on the Upper Secondary School Equivalency Examination )
- [8] A person who is enrolled in a university in accordance with the provisions of Article 90, Paragraph 2 of the School Education Act (Act No. 26 of 1947) and has been deemed to possess scholastic ability appropriate to receiving a university education at This University
- [9] A person who has attained the age of 18 years and has been recognized through a separate admission screening at This University as having academic ability equal to, or greater than, a person graduated from high school

Application Procedure for Admission:

Article 12. A person applying for admission to This University must submit to This University the separately prescribed documents (hereafter, Application Documents) with a payment of 17,000 yen for the examination fee (10,000 yen for the Evening Course) within a specified period.

- (2) In the entrance examination stipulated in the Article 13, a selection shall take place based on the Application Documents (hereafter, 1<sup>st</sup> Selection). The examination fee in cases where a selection limited to successful applicants takes place based on scholastic ability and other matters (hereafter, 2<sup>nd</sup> Selection) shall be 4,000 yen for the 1<sup>st</sup> Selection (2,200 yen for the Evening Course) and 13,000 yen for the 2<sup>nd</sup> Selection (7,800 yen for the Evening Course), notwithstanding the stipulations of the preceding paragraph.
- (3) The stipulations in Paragraph 1 shall apply mutatis mutandis in cases where application for admission is based on stipulations in Article 14, Article 18, or Article 38. However, the examination fee shall be 30,000 yen (18,000 yen for the Evening Course).

Examination Fee:

Article 12-2. Notwithstanding the stipulations of the preceding article, a person with special circumstances may be exempt from paying the examination fee.

(2) Matters necessary to the exemption of the examination fee shall be separately prescribed.

Entrance Examination:

Article 13. An entrance examination shall be held for applicants for admission.

(2) The entrance examination set forth in the preceding paragraph shall be separately prescribed.

Admission of a University Graduate & Readmission:

Article 14. Notwithstanding the stipulations in the preceding article, This University may allow the admission of a university graduate, following screening, to an undergraduate program provided the person falls under one of the following items.

[1] A person who has graduated from a school at This University and is applying for admission to another department or cluster in the same school, or to another school

[2] A person who has graduated from a school at another university and is applying for admission to This University

[3] A person who has been awarded an undergraduate degree from the National Institution for Academic Degrees and Quality Enhancement of Higher Education in accordance with stipulations set forth in Article 104, Paragraph 7 of the School Education Law (Act No. 26 of 1947) and is applying for admission to This University

(2) Notwithstanding the stipulations in the preceding paragraph, This University may not allow admission of a university graduate due to the admission capacity, etc.

(3) Notwithstanding the stipulations in the preceding article and Paragraph 1, This University may allow readmission of a person, following a screening process, who has withdrawn (except due to dismissal as disciplinary punishment) or been removed (except as stipulated in Article 43, Paragraph 2) from This University and is applying for readmission to the same school, limited to within 4 years since the withdrawal or removal. However, if the school, department, or cluster to which the person belonged at the time of withdrawal or removal has been reorganized and thus the person cannot apply for admission to the school, etc. to which the person belonged at the time of withdrawal or removal, the person may apply to a school, etc. determined through consultation between the related schools.

(4) Notwithstanding the stipulations in the preceding paragraph, This University may not allow readmission due to the admission capacity, etc.

(5) In the case of Paragraph 3 whereby a removed person passes the screening process, the person shall complete the admission procedure as stipulated in Article 16 and pay the amount equivalent to the unpaid admission fee and tuition.

(6) The approval of credits acquired prior to admission, term of study, and maximum period of enrollment for a person applying for admission based on Paragraph 1 or Paragraph 3 shall be conducted by the school dean following deliberations at the faculty meeting in the relevant school.

#### Selecting Successful Applicants:

Article 15. The president shall select the persons to be granted admission following deliberations at the faculty meeting in each school.

#### Admission Procedure:

Article 16. A person intending to accept the offer of admission must submit the separately prescribed documents (hereafter, Admission Documents) and pay an admission fee of 282,000 yen (141,000 yen for the Evening Course) by a designated date.

#### Admission Fee Exemption & Deferment of Collection:

Article 16-2. Notwithstanding the stipulations of the preceding article, a person with special circumstances may be exempt from paying the entire or half of the admission fee, or may defer collection thereof.

(2) Notwithstanding the stipulations of the preceding article, a student receiving a scholarship through the Hiroshima University Phoenix Scholarship System (hereafter, Phoenix Scholarship Student), which is specified separately, may be exempt from paying the entire admission fee.

(3) In addition to the prescriptions set forth in the preceding two paragraphs, matters necessary to the exemption or deferment of the admission fee shall be separately prescribed.

#### Offer of Admission:

Article 16-3. The president shall offer admission to persons who have completed the admission procedure set forth in Article 16 (including persons whose application for exemption from, or deferment of, the admission fee, and persons whose application to be a Phoenix Scholarship Student is pending).

#### Refund of the Examination Fee & Admission Fee:

Article 17. Examination fees and admission fees that have already been paid shall not be refunded.

(2) Notwithstanding the stipulations of the preceding paragraph, when any of the following items apply, the fees stipulated in the applicable item shall be refunded at the request of the person who made the payment.

[1] In the entrance examination set forth in Article 13, in cases where the 1<sup>st</sup> Selection takes place and a 2<sup>nd</sup> Selection occurs, 13,000 yen (7,800 yen for the Evening Course) shall be refunded to a person who paid the examination fee but did not pass the 1<sup>st</sup> Selection.

[2] Following acceptance of the application for general selection based on stipulations set forth in Article 12, Paragraph 1, 13,000 yen (7,800 yen for the Evening Course) shall be refunded to a person who paid the examination fee, but it turns out that whose application is unacceptable due to insufficient examination subjects on the Common Test for University Admissions or other reasons.

[3] An amount equivalent to the examination fee shall be refunded when a person who paid the examination fee did not submit the Application Documents.

[4] An amount equivalent to the admission fee shall be refunded when an individual who paid the admission fee did not submit the Admission Documents

Transfer Admission:

Article 18. Notwithstanding the stipulations in Article 11 and Article 14, a person applying for admission to This University as a 2<sup>nd</sup> or 3<sup>rd</sup>-year student may be granted a transfer admission following an examination.

(2) Matters necessary to the handling of a transfer admission shall be separately prescribed.

#### Chapter 3 Curricula

Curricula Organization & Methods of Completion, etc.:

Article 19. Based on the principles of This University, the curricula at This University shall be a systematically organized educational program that utilizes the attributes of the schools, departments, and clusters of study to establish class subjects necessary to achieve educational goals.

(2) Class subjects shall be divided into general education courses and specialized education courses.

(3) The class subjects stipulated in the preceding paragraph and method of completing classes shall be prescribed in the rules regarding general education and by-laws of each school.

(4) When the establishment of detailed divisions for completing the curricula is necessary, they shall be as prescribed in the rules regarding general education and by-laws of each school.

(5) Matters necessary to the education program shall be separately prescribed.

Class Methods:

Article 19-2. Classes shall be conducted as any of or any combination of lectures, seminars, laboratory work, practical training, and skills practice.

(2) The classes set forth in the preceding paragraph shall utilize various media in a highly advanced manner and may be completed in a location other than the classroom, etc. where said classes are conducted, as provided for by the Minister of Education, Culture, Sports, Science and Technology.

(3) The classes set forth in Paragraph 1 may be completed in a foreign country. The same shall apply in cases where classes are completed at a location other than the classroom, etc. where said classes are conducted, by utilizing various media in a highly advanced manner, as stipulated in the preceding paragraph.

#### Standard for Calculating Credits:

Article 19-3. When stipulating the number of credits for each class subject, the standard shall be a requirement of 45 hours of study for 1 credit of a class subject. In accordance with the class method, and in consideration of teaching effectiveness based on said class and the study required outside of class hours, the number of credits shall be calculated according to the following standards.

[1] Lectures and seminars shall be 1 credit for class time prescribed in rules, etc. (for general education courses, rules related to general education, and for specialized education courses, the by-laws of each school; hereafter, the same shall apply), within a range of 15 hours to 30 hours.

[2] Laboratory work, practical training, and skills practice shall be 1 credit for class time prescribed in rules, etc., within a range of 30 hours to 45 hours. However, skills practice conducted by individual instruction in the area of arts, etc. may be 1 credit for class time prescribed in rules, etc.

[3] In the case of classes for a single class subject conducted through a combination of 2 or more methods that include lecture, seminar, laboratory work, practical training, or skills practice, in accordance with that combination and in consideration of the standard stipulated in the preceding Item 2, classes shall be 1 credit for class time prescribed in rules, etc.

(2) Notwithstanding the stipulations in the preceding paragraph, in regard to class subjects such as graduation theses, graduation research, and graduation products, when deemed appropriate to grant credits by evaluating the achievement of such learning, the number of credits may be prescribed in light of the learning, etc. required for these classes.

#### Granting of Credits:

Article 19-4. A person who has completed a single class subject shall be granted a predetermined credit based on an examination and attendance. However, in regard to the class subjects set forth in the preceding Article, Paragraph 2, credits may be granted by evaluating the achievement of the learning based on appropriate methods prescribed by each school.

#### Performance Assessment of Class Subjects:

Article 19-5. The assessment of performance in a class subject shall utilize the 5 levels of excellent, superior, good, fair, and poor. Excellent, superior, good, and fair shall be passing grades, while poor shall be a failing grade.

#### Maximum Course Registration:

Article 20. In regard to the number of credits a student must acquire as a requirement for graduation, the maximum number of credits a student may register for in 1 year or 1 semester shall be as prescribed in the by-laws of each school so that a student completes an appropriate number of class subjects over each year.

- (2) As provided for in the by-laws of each school, a student who has acquired the predetermined credits with superior results may register for class subjects in the next semester in excess of the maximum number of credits.

#### Japanese Language Courses & Courses Related to Japan:

Article 21. Japanese language courses and courses related to Japan shall be established and class subjects related to these courses may be provided for international exchange students and persons other than international exchange students who have received an education in a foreign country for a length of time.

- (2) The class subjects set forth in the preceding paragraph shall be established at the Morito Institute of Global Higher Education.
- (3) When credits are acquired through completion of classes stipulated in the previous paragraph, of the credits that should be obtained as requirement for graduation, class subjects and credits, etc. that may be substituted for credit for said class subjects shall be prescribed in the by-laws of each school.

#### Long-term Completion of Curricula:

Article 22. When a student expresses the intent to systematically complete the curricula and graduate over a certain period of time that exceeds the term of study due to circumstances such as having an occupation, that systematic completion (hereafter, Long-term Completion of Curricula) may be approved, provided it does not present a hindrance to said school.

- (2) Matters necessary to the handling of Long-term Completion of Curricula shall be separately prescribed.

#### Completion of Curricula:

Article 23. A student must complete the predetermined curricula while enrolled in This University.

- (2) The curricula shall be completed through the acquisition of credits following the completion of predetermined class subjects.

#### Acquiring Necessary Qualifications for the Granting of Teaching Credentials:

Article 24. A person intending to acquire qualifications necessary for the granting of teaching credentials must obtain the required credits prescribed in the Teacher's License Act (Act No. 147 of 1949) and the Ordinance for Enforcement of the Teacher's License Act (Ordinance of the Ministry of Education No. 26 of 1954).

(2) The types of teacher's certifications that may be obtained for said required qualifications at This University shall be prescribed in the by-laws of each school.

Completion of Class Subjects at Other Schools, etc.:

Article 25. In addition to class subjects (limited to those available to school students; hereafter the same shall apply in this Article) prescribed in Article 23, Paragraph 2, a student may complete class subjects (limited to those available to school students; hereafter the same shall apply in this Article) at other schools, graduate courses, basic organizations for the delivery of inter-graduate school programs, attached research institute, headquarters for education, national joint usage facilities, and joint education and research facilities on campus (hereafter, referred to as Other Schools, etc. in this Article).

(2) When a student intends to complete class subjects at Other Schools, etc., the completion shall be as prescribed by the school to which the student belongs and said Other Schools, etc.

Completion of Graduate School Class Subjects:

Article 26. When a student wishes for admission to a graduate school at This University and the school to which the student belongs deems it to be educationally beneficial, after obtaining the permission of the dean of the graduate school or the basic organization for the delivery of inter-graduate school programs to which the student is applying, the student may complete class subjects at the said graduate school or the basic organizations for the delivery of inter-graduate school programs (limited to those applicable to graduate school students; hereafter the same shall apply in this Article).

(2) Matters necessary to a student completing class subjects at a graduate school at This University shall be separately prescribed.

Organizational Training, etc. to Improve Educational Content, etc.:

Article 27. This University shall implement organizational training and research for the purpose of improving class content and methods.

Chapter 4 Completing Classes at other Universities, etc.

Student Exchange:

Article 28. A student may complete class subjects at another university or junior college with the permission of the president.

(2) When deemed educationally beneficial, the school may regard credits that a student acquired in accordance with the preceding paragraph as credits acquired by completing class subjects at This University, following deliberations at the faculty meeting in said school.

(3) The number of credits that may be regarded as acquired in accordance with the stipulations set forth in the preceding paragraph shall not exceed 60 credits, together with

the number of credits granted or regarded as acquired pursuant to stipulations in Paragraph 3 and Paragraph 4 of the following Article, Paragraph 1 of Article 30, and Paragraph 1 and Paragraph 2 of Article 31.

(4) A student from another university or junior college may complete class subjects at This University with the permission of the president.

(5) Matters necessary to student exchange shall be separately prescribed.

Studying Abroad, etc.:

Article 29. A student who intends to study at a university or junior college in a foreign country may study abroad with the permission of the president.

(2) The period of the study abroad set forth in the preceding paragraph shall be included in the period of enrollment at This University.

(3) When deemed educationally beneficial, the school may regard credits acquired by a student in accordance with Paragraph 1 as credits acquired by completing class subjects at This University, following deliberations at the faculty meeting in said school.

(4) The stipulations set forth in the preceding paragraph shall apply *mutatis mutandis* in cases where a student completes class subjects in Japan conducted by a foreign university or a junior college by correspondence education, and where a student completes class subjects in Japan conducted by a foreign educational facility positioned as a facility that has the curriculum of a university or junior college under said foreign country's school education system and designated separately by the Minister of Education, Culture, Sports, Science and Technology.

(5) The number of credits that may be regarded as acquired in accordance with the stipulations set forth in the preceding two paragraphs shall not exceed 60 credits, together with the number of credits that may be granted or regarded as acquired pursuant to stipulations in Paragraph 2 of the preceding Article, Paragraph 1 of the following Article, and Paragraph 1 and Paragraph 2 of Article 31.

(6) A student from a foreign university or a junior college, or an educational facility positioned as a facility that has the curriculum of a foreign university or junior college under said foreign country's school education system and designated separately by the Minister of Education, Culture, Sports, Science and Technology, may complete class subjects at This University with the permission of the president.

(7) Matters necessary to studying abroad, etc. shall be separately prescribed.

Learning at Educational Facilities, etc. other than Universities:

Article 30. When deemed educationally beneficial, the school may deem a student's learning at a junior college or at an advanced course at a college of technology or other learning specified separately by the Minister of Education, Culture, Sports, Science and

Technology to be completion of class subjects at This University and grant credits, following deliberations at the faculty meeting in said school.

- (2) The number of credits that may be granted in accordance with the stipulations set forth in the preceding paragraph shall not exceed 60 credits, together with the number of credits that may be granted or regarded as acquired pursuant to stipulations in Article 28, Paragraph 2, Paragraph 3 and Paragraph 4 of the preceding Article, and Paragraph 1 and Paragraph 2 of the following Article.
- (3) A student from a junior college, an advanced course at a college of technology, etc. may complete class subjects at This University with the permission of the president.
- (4) Matters necessary to learning at educational facilities, etc. other than This University shall be separately prescribed.

Approval of Credits Acquired Prior to Admission as a 1<sup>st</sup>-Year Student:

Article 31. When deemed educationally beneficial, a school may regard credits that a student admitted in the 1<sup>st</sup> year has acquired by completing class subjects at a university or junior college (including a foreign university or junior college, or a foreign educational facility positioned as a facility that has the curriculum of a foreign university or junior college under said foreign country's school education system and designated separately by the Minister of Education, Culture, Sports, Science and Technology) prior to being admitted to This University (including credits acquired as a credited auditor) as credits acquired by completing class subjects at This University.

- (2) When deemed educationally beneficial, the school may regard a student's learning, as stipulated in Paragraph 1 of the preceding Article, that occurred prior to being admitted to This University in the 1<sup>st</sup> year, as completion of class subjects at This University and grant credits.
- (3) The number of credits that may be granted or regarded as completed in accordance with the stipulations in the preceding two paragraphs shall not exceed 60 credits, together with the number of credits that may be granted or regarded as having been acquired under Paragraph 2 of Article 28, Paragraph 3 and Paragraph 4 of Article 29, and Paragraph 1 of the preceding Article, excluding credits acquired at This University (including credits acquired as a credited auditor).
- (4) Matters necessary to the approval of credits, etc. acquired prior to admission in accordance with the stipulations set forth in the preceding three paragraphs shall be separately prescribed.

#### Chapter 5 Leave of Absence & Withdrawal

Leave of Absence:

Article 32. A student unable to pursue learning for at least 3 consecutive months due to illness or other compelling reasons may take a leave of absence with the permission of the relevant school dean.

- (2) The leave of absence may not exceed a consecutive period of 1 year. However, when special circumstances exist, a further leave of absence of up to 1 year shall be permitted.
- (3) Notwithstanding the stipulations of the preceding two paragraphs, a person falling under Article 17, Item 10 of the Hiroshima University Graduate School Regulations (January 15, 2008 Regulation No. 2) who is a student in the School of Medicine/Medicine, when admitted to a doctoral course in the Division of Biomedical Sciences/Graduate School of Biomedical and Health Sciences, may take a leave of absence with the permission of the relevant school dean.
- (4) The leave of absence set forth in the preceding paragraph may not exceed a consecutive period of 4 years. However, when special circumstances exist, a further leave of absence of up to 1 year shall be permitted.
- (5) Notwithstanding the stipulations of Paragraph 1 and Paragraph 2, when a international exchange student from Korea accepted by the Japan-Korea Joint Exchange Program for Science and Engineering Students implemented by the Ministry of Education, Culture, Sports, Science and Technology is called up for military service, the student may take a leave of absence with the permission of the relevant school dean.
- (6) The period of leave of absence set forth in the preceding paragraph shall be the term of military service.
- (7) When the reason for such leave of absence ceases to exist, even during the leave of absence, a student may re-enroll with the permission of the relevant school dean.

Article 33. The cumulative period of leave of absence (excluding the leave of absence stipulated in Paragraph 4 and Paragraph 6 of the preceding Article) shall not exceed the term of study in the school to which a student belongs.

Article 34. The period of leave of absence shall not be included in the period of enrollment.

Withdrawal:

Article 35. A student who intends to withdraw must submit a petition to the president and receive permission.

#### Chapter 6 Transferring Schools, Departments & Universities

Transferring Schools:

Article 36. A student applying for transfer to another school must receive permission from the president following deliberations at the faculty meeting in the school to which s/he belongs and the school into which s/he is applying to transfer.

- (2) Matters necessary for the handling of school transfer shall be separately prescribed.

Transferring Departments, etc.:

Article 37. A student applying for transfer to another department or cluster of study within the school to which s/he belongs must receive permission from the relevant school dean.

(2) A student in the School of Law or School of Economics applying for transfer to another course within the school to which s/he belongs must receive permission from the relevant school dean.

Transferring Universities:

Article 38. A student applying for transfer from another university shall obtain permission from the president following deliberations at the faculty meeting in the relevant school.

In this case, approval for credits acquired prior to admission, term of study, and maximum period of enrollment shall be conducted by the school dean following deliberations in the faculty meeting at the relevant school.

(2) A student intending to transfer to another university must receive permission from the president following deliberations at the faculty meeting in the school to which the student belongs.

Chapter 7 Reward and Disciplinary Punishment & Removal from Register

Reward:

Article 39. When a student demonstrates behavior that is deserving of reward, the president may recognize the behavior.

(2) Matters necessary to the recognition of reward shall be separately prescribed.

Disciplinary Punishment:

Article 40. When a student violates the rules of This University, disrupts the order within This University, or conducts any act against its duty as a student, the president shall have disciplinary punishment for the behavior.

(2) The types of disciplinary punishment shall be reprimand, suspension, and dismissal.

(3) Matters necessary to disciplinary punishment shall be separately prescribed.

Article 41. When a student falls under any of the following items, an order for dismissal may be given as disciplinary punishment.

(1) A person who is recognized as demonstrating delinquent behavior that is not expected to improve

(2) A person who is recognized as having poor scholastic ability, etc. and being unlikely to complete his/her studies

(3) A person who demonstrates irregular attendance with no justifiable reason

(4) A person who significantly disrupts the order within This University

(5) A person who conducts any act extremely against its duty as a student

Article 42. When a suspension lasts at least 3 months, that period shall not be included in the term of study.

Removal from Register:

Article 43. When a student falls under any of the following items, the president may remove that student from the register, following deliberations at the faculty meeting in the relevant school.

- (1) A person not approved for exemption from the admission fee or postponement of payment of the admission fee, a person who is approved for exemption from half the admission fee or postponement of payment, or a person not selected as a Phoenix Scholarship Student, who has not paid the admission fee that is due
- (2) A person who has reached the predetermined period of enrollment, but has not been approved for graduation
- (3) A person who is negligent about paying tuition and has not paid the tuition even after receiving demand for payment

#### Chapter 8 Graduation & Conferment of Degrees

##### Graduation Requirements:

Article 44. A person enrolled for at least the term of study stipulated in Article 4 who has completed the predetermined class subjects and has acquired the number of credits required for graduation as prescribed by each school (124 credits or more; 188 credits or more for the School of Medicine/Medicine and School of Dentistry/Dentistry, and 186 or more for the School of Pharmaceutical Sciences/Pharmaceutical Sciences (including 20 or more credits in practical training carried out in a university-affiliated hospital, other hospitals, or pharmacies with the aim of cultivating practical abilities related to clinical pharmaceutical work necessary to practice as a pharmacist in the future)) shall be approved for graduation by the president, following deliberations at the faculty meeting in the relevant school.

(2) Of the credits required for graduation based on the stipulations set forth in the preceding paragraph, the number of credits that may be acquired in accordance with class methods set forth in Article 19-2, Paragraph 2 are as follows.

[1] When the number of credits required for graduation is 124 (188 credits for the School of Medicine/Medicine and the School of Dentistry/Dentistry and 186 credits for the School of Pharmaceutical Sciences/Pharmaceutical Sciences; hereafter, the same shall apply), the number shall not exceed 60 credits.

[2] When the number of credits required for graduation exceeds 124, and if 64 or more credits (128 credits for the School of Medicine/Medicine and the School of Dentistry/Dentistry and 126 credits for the School of Pharmaceutical Sciences/Pharmaceutical Sciences) have been acquired in accordance with the class methods set forth in Article 19-2, Paragraph 1, an excess of 60 credits may be acquired.

##### Early Graduation:

Article 45. A student at This University (excluding a student enrolled in the School of Medicine/Medicine, the School of Dentistry/Dentistry, and the School of Pharmaceutical Sciences/Pharmaceutical Sciences) who has been enrolled in a relevant school for at least 3 years (including schools stipulated as equivalent by the Minister of Education, Culture, Sports, Science and Technology) and has been recognized as having acquired the credits required for graduation with high marks, and in cases where the requirements prescribed in Article 147 of the School Education Law Regulations (Act No. 11, 1947) have been fulfilled in the said school, may be approved for graduation by the president, following deliberations at the faculty meeting in the relevant school, notwithstanding the stipulations set forth in Article 4.

#### Conferment of Diplomas & Degrees:

Article 46. The president shall grant a diploma and university degree to a person approved for graduation.

(2) Matters necessary to the conferment of a university degree shall be separately prescribed.

#### Chapter 9 Tuition

##### Tuition:

Article 47. Annual tuition shall be 535,800 yen (267,900 yen for the Evening Course).

However, the amount for a person approved for Long-term Completion of Curricula in accordance with Article 22 shall be calculated by dividing the amount obtained by multiplying the annual tuition amount by the number of years equal to the remaining term of study at the time the Long-term Completion of Curricula was approved, by the number of years of said Long-term Completion of Curricula (when that amount contains a fraction less than 10 yen, the amount shall be rounded up).

- (2) The tuition prescribed in the preceding paragraph shall be divided into first semester and second semester payments, and an amount equal to one half of the annual amount shall be paid in each semester. The first semester payment must be made in April, and the second semester payment must be made in October.
- (3) Notwithstanding the stipulations of the preceding paragraph, when paying the tuition for the first semester, payment may also be made for the second semester of the said year.
- (4) Notwithstanding the stipulations of the previous two paragraphs, in the year of admission, tuition for the first semester, or the first semester and second semester, may be paid at the time admission is granted.
- (5) Notwithstanding the stipulations of Paragraph 2 and the previous paragraph, a person listed in the following items must pay tuition by the day noted in the applicable item.

[1] A person who undergoes admission, re-enrollment, university transfer, transfer admission, or readmission partway through a term due to special circumstances must

pay the amount for that term calculated on a monthly basis by the last day of the month in which the day that granted admission falls

- [2] A person who graduates partway through the academic year must pay the amount for that term calculated on a monthly basis by the due date for each term prescribed in Paragraph 2.
- [3] A person permitted payment in monthly installments must pay on the last day of the month. However, when the last day falls during a period of suspension of business, payment must be made by the day before the start of said period of suspension of business.
- [4] A person whose approval for exemption, postponement, or payment by monthly installment has been cancelled, or whose grace period is ended must pay by the last day of the month in which the day of the cancellation of approval, or end of grace period, falls.
- (6) The amount calculated on a monthly basis prescribed in the previous items shall be an amount equivalent to one twelfth of the annual tuition prescribed in Paragraph 1 (when that amount contains a fraction less than 10 yen, the amount shall be rounded up).
- (7) When a person already authorized for Long-term Completion of Curricula is approved for abbreviation of the period of Long-term Completion of Curricula, in accordance with the period following said abbreviation, an amount calculated by subtracting the total tuition that must be paid during the period of said person's enrollment (for partial academic years, it shall be the period until the conclusion of said academic year; hereafter, the same shall apply) from the amount obtained by multiplying the number of years (when that period contains a fraction of less than 1 year, the number of years shall be rounded up; hereafter the same shall apply) said person is enrolled by the tuition prescribed in accordance with the provisions of the proviso to Paragraph 1, shall be paid at the time the abbreviation of the period of Long-term Completion of Curricula is approved. However, when the period following the said abbreviation is equal to the period of the term of study, an amount shall be paid that is calculated by subtracting the total tuition that must be paid for the enrollment period of said person from an amount obtained by multiplying the number of years said person was enrolled by the tuition prescribed in Paragraph 1.
- (8) When the tuition is not paid by the predetermined due date, demand for payment will be made by a posted notice, etc. to the student, parents, etc.

Tuition Exemption and Postponement of Collection:

Article 48. Approval may be given for exemption from the entire tuition, or half the tuition, or postponement of collection, or payment by monthly installments may be approved for a student that has difficulty making payment due to economic reasons and recognized as

demonstrating outstanding academic performance, or a student recognized as having extreme difficulty paying tuition due to special circumstances.

- (2) In addition to the stipulations set forth in the preceding paragraph, a Phoenix Scholarship Student may be exempt from the entire tuition.
- (3) In addition to the stipulations in the previous two paragraphs, a scholarship student in the separately prescribed Hiroshima University Hikarikagayaku Scholarship Program may be exempt from the entire tuition.
- (4) In addition to the stipulations in the previous three paragraphs, matters necessary to the exemption of tuition and postponement of collection shall be separately prescribed.

Tuition for Students on Leave of Absence:

Article 49. A student is exempt from paying tuition while on leave of absence.

Tuition for Students that Withdraw, etc.:

Article 50. A student that withdraws or is dismissed as disciplinary punishment must also pay tuition for that term.

- (2) A person suspended from school must also pay tuition during that period.

Refund of Tuition:

Article 51. Tuition that has already been paid shall not be refunded.

- (2) Notwithstanding the stipulations of the preceding paragraph, when a person who has already paid tuition falls under any one of the following items, an amount equal to the tuition prescribed in the applicable item shall be refunded in accordance with the request of the person (or the student's parent in cases of Item 4 hereunder) who made the payment.
  - (1) When admission is withdrawn by the time of entrance into This University, the entire tuition shall be refunded.
  - (2) When permission is granted for a leave of absence, an amount equal to the tuition for that approved period shall be refunded.
  - (3) When permission is granted for withdrawal prior to September 30<sup>th</sup>, an amount equal to the tuition for the second semester shall be refunded.
  - (4) When the student has passed away, the amount equal to the tuition for the month following the one wherein the student passed away and thereafter shall be refunded.

Chapter 10 Research Students, Credited Auditors, Short-term International Exchange Students & International Students, etc.

Research Students:

Article 52. When a person who is not a student at This University applies to conduct research on specific matters at This University, admission as a research student may be granted by selection, provided it does not present a hindrance to education and research.

- (2) Matters necessary to research students shall be separately prescribed.

#### Credited Auditors:

Article 52-2. When a person other than a student at This University applies to complete one or more class subjects at This University, admission as a credited auditor may be granted by selection, provided it does not present a hindrance to education and research.

(2) Matters necessary to credited auditors shall be separately prescribed.

#### Short-term International Exchange Students:

Article 52-3. When a student in a university, etc. in a foreign country applies to attend seminars provided by This Graduate School as part of the curricula of the university, etc. in a foreign country, s/he may be admitted as a short-term international exchange student upon screening, provided it does not present a hindrance to education and research.

(2) A university, etc. in a foreign country is as follows:

[1] A university or college (including higher education institution other than university) in a foreign country

[2] An educational institution designated by the educational system of a foreign country as offering a curriculum of a university or college in that country, which is separately designated by the Minister of Education, Culture, Sports, Science and Technology

[3] The United Nations University (established based on the December 11, 1972 United Nations General Assembly resolution stipulated in Article 1, Paragraph 2 of the Act on Special Measures (Act No. 72 of 1976) incidental to enforcement of the agreement between the United Nations and Japan regarding the headquarters of the United Nations University)

(3) Particulars regarding the short-term international exchange students shall be provided separately.

#### International Students:

Article 53. A foreign person who applies for admission without complying with stipulations set forth in Article 13, Article 14, and Article 18 may be granted admission by selection as an international student.

#### Credit Program:

Article 53-2. A credit program may be established at This University as a special course as stipulated in Article 105 of the School Education Law, for the purpose of utilizing the education and research resources at This University to actively share learning opportunities with adults in the workforce, etc.

(2) Matters necessary to the credit program shall be separately prescribed.

#### Extension Courses:

Article 54. Extension courses may be established at This University for the purpose of broadly opening up the education and research at This University to society to actively share learning opportunities with regional residents.

(2) Matters necessary to extension courses shall be separately prescribed.

Chapter 11 Welfare Facilities, etc.

Welfare Facilities:

Article 55. Student dormitories and other welfare facilities shall be constructed at This University.

(2) Matters necessary to the facilities set forth in the preceding paragraph shall be separately prescribed.

Miscellaneous Provisions:

Article 56. The school dean shall report revisions to the school by-laws to the president.

(2) In addition to the provisions prescribed here, matters necessary to student learning at schools shall be separately prescribed.

Supplementary Provisions:

1. This provision shall come into effect from April 1, 2004.
2. The admission capacity for the Evening Course/Faculty of Law and faculty, and the admission capacity for all faculties shall be as shown in the following table from FY2004 until FY2006, regardless of stipulations set forth in the Appended Table.
