Guide to Issuing a Certificate Regarding Involvement in Social Contribution Activities

Purpose:

No. 1. This Guide prescribes matters necessary to the issuance of a certificate to students at Hiroshima University who have carried out social contribution activities (hereafter, Students), based on stipulations in Article 56 of Hiroshima University General Provisions (April 1, 2004 Regulation No. 2) (including cases of the mutatis mutandis application to Article 56 of Hiroshima University Graduate School Regulations (January 15, 2008 Regulation No. 2) and Article 24 of Hiroshima University Special Needs Education: Regulations for the Program in Special Education (March 20, 2007 Regulation No. 44)).

Aims:

No. 2. This Guide aims to support students' unrestricted involvement in social contribution activities through the issuance of a certification to individuals who have carried out social contribution activities such as volunteer work, lifesaving activities, crime prevention, and disaster prevention.

Activities Eligible for Certification:

No. 3. In cases where a student enrolled in a school, graduate school, or advanced course at This University (hereafter, School, etc.) has carried out one of the following stipulated activities, s/he may apply for the issuance of certification by submitting Appended Form No. 1 to the dean of the School, etc. of enrollment (hereafter, Dean of Enrollment).

- (1) Support activities that assist students that have physical disabilities with their studies, etc.
- (2) Support activities that counsel students through the role of Peer Supporter
- (3) Activities listed in the appended table to the Act to Promote Specified Non-profit Activities (Act No. 7, 1998) that are carried out by an individual Student or a group made up of Students.
- (4) Other activities equivalent to the activities listed in the preceding 3 items

Recommendation from the Dean of Enrollment:

No. 4. When an application for the issuance of the certificate set forth in No. 3 is submitted, the Dean of Enrollment shall review the content and make a recommendation to the president using Appended Form No. 1.

Certificate Issuance:

No. 5. The president shall issue a certificate using Appended Form No. 2, based on the recommendation from the Dean of Enrollment.

Retraction:

No. 6. In cases where a Student makes a false statement or it becomes clear that a false statement has been made, the president shall retroactively retract the certification.

Administration:

No. 7. Administration related to the issuance of the certificate shall be carried out by

the General Student Support Center.

Mutatis Mutandis Application:

No. 8. The stipulations set forth in this Guide shall apply mutatis mutandis to research students (including foreign research students) and credited auditors.

Supplementary Provisions

This guide shall come into effect from April 1, 2004.

This regulation shall come into effect from July 18, 2023, and the stipulations set forth in the Guide to Issuing a Certificate Regarding Involvement in Social Contribution Activities revised in accordance with this regulation shall be applied from April 1, 2023.
