# Chapter 1 General Principles

## Objectives:

Article 1 These Policies and Regulations provide for the matters necessary for organizations and management, etc., of Hiroshima University, which are established by Hiroshima University, National University Corporation and its Corporation, incorporated under the National University Corporation Act (Act No. 112 of 2003. Hereinafter referred to as "Corporation Act").

#### Definitions:

Article 2 Hiroshima University, National University Corporation and Hiroshima University provided for in the preceding Article shall collectively be referred to as Hiroshima University (hereinafter referred to as "University"), except as otherwise provided.

#### Address of Office:

Article 3 The principal office of the University shall be located at 1-3-2 Kagamiyama, Higashi-Hiroshima City, Hiroshima.

## **Guiding Principles:**

Article 4 The University adheres to the founding principles of "a single unified peaceful university." Based on the guiding principles set forth below, the University develops individuals who will take up the challenge and responsibility of leading the future, inherit, develop and expand fields of scholarship and contribute to the development of local, regional and international communities.

- (1) The Pursuit of Peace
- (2) The Creation of New Forms of Knowledge
- (3) The Nurturing of Well-Rounded Human Beings
- (4) Collaboration with Local, Regional, and International Communities
- (5) Continuous Self-Development

#### Self-Assessment, etc.:

Article 5 In order to contribute to improvement of education and research standards under the School Education Act (Act No. 26 of 1947), Article 109, paragraph 1, the University shall conduct self-assessments (hereinafter in this Article referred to as "Self-Assessment") on the

- status of education and research, organization and management and facilities and equipment (hereinafter in this Article referred to as "Education and Research, etc.") of the University and shall publish the results thereof.
- 2. Under the School Education Act, Article 109, paragraph 2, the University shall receive regular assessments on the comprehensive status of Education and Research, etc., of the University by a person certified by the Minister of Education, Culture, Sports, Science and Technology (hereinafter in this Article referred to as "Accreditation") in addition to the Self-Assessment provided for in the preceding paragraph.
- 3. Under the School Education Act, Article 109, paragraph 3, the University shall receive regular Accreditation of the status of education programs of professional graduate schools, faculty organization and any other education and research activities in addition to the Accreditation provided for in the preceding paragraph.
- 4. Based on the results of Self-Assessment provided for in paragraph 1, Accreditation provided for in paragraph 2, and other assessments, the University shall endeavor to make improvements and reforms.
- 5. Matters necessary for Self-Assessment shall be stipulated separately.

Article 6 The following schools shall be established at the University.

### **Graduate Schools:**

Article 7 Graduate schools shall be established at the University.

2 The following graduate schools and basic organizations for the delivery of inter-graduate school programs shall be established.

Graduate School of Humanities and Social Sciences

Graduate School of Advanced Science and Engineering

Graduate School of Integrated Sciences for Life

Graduate School of Biomedical and Health Sciences

Graduate School of Innovation and Practice for Smart Society

3 As a program organization, an Organization of the World-leading Innovative Graduate Education

Programs shall be established at the graduate schools.

#### Academic Division:

Article 8 As a faculty organization, an Academic Division shall be established at the University.

- 2. In each Academic Division, the Head of the Academic Division shall be assigned, which is assumed by the President of the University.
- 3. Matters necessary for each Academic Division shall separately be determined.

#### Advanced Course:

Article 9 The following advanced course shall be established at the University. Special Education Major Program

#### Attached Research Institute:

Article 10 A Research Institute for Radiation Biology and Medicine shall be established at the University as an attached research institute to promote advanced research on the biological effects of radiation and application of such research for the treatment and prevention of health disorders caused by the effects of the A-bomb and radiation.

- 2. At the Research Institute for Radiation Biology and Medicine, a relevant division shall be established.
- 3. At the Research Institute for Radiation Biology and Medicine, university faculty and other individuals who are engaged in the same fields of research as the Research Institute for Radiation Biology and Medicine shall be granted use of the Institute.

# Hospital:

Article 11 A hospital shall be established at the University as an education and research institute for medicine in order to function as a medical care facility of medicine and dentistry and to contribute to improvement of regional medicine through medical care.

- 2. At the Hospital, Clinical Departments and Central Clinical Facilities shall be established.
- 3. At the Hospital, the Division of Pharmaceutical Services, Division of Nursing and Division of Clinical Support shall be established.

#### Library:

Article 12 A Library shall be established at the University.

### Headquarters for Education:

Article 12-2 At the University, Headquarters for Education shall be established in order to promote planning, assessment and improvement for selection of enrolled students, improvement in the quality of education and strengthening of educational ability at the undergraduate level, graduate level and Special Education Major Program and to provide liberal arts education.

### Attached Research Institute (School, etc.):

Article 13 The following attached educational facilities and research institutes (hereinafter in this Article referred to as "Attached Institutes") set forth in the column on the right to the schools,

graduate schools and attached research institutes (hereinafter in this Article referred to as "Schools, etc.") set forth in the column on the left.

2. Matters necessary for attached institutes shall be determined by the School, etc. International Premier Research Center:

Article 13-2. International Institute for Sustainability with Knotted Chiral Meta Matter shall be established in the University as an international premier research center in order to promote studies in the framework of the World Premier International Research Center Initiative promoted by the Japanese Ministry of Education, Culture, Sports, Science and Technology and other international, cutting-edge studies.

### National Joint Usage Facilities:

Article 14 As national joint usage facilities, Research Institute for Synchrotron Radiation Science shall be established at the University.

2. At the Research Institute for Synchrotron Radiation Science, university faculty and other individuals who are engaged in the same fields of research as the research of objectives of the Research Institute for Synchrotron Radiation Science shall be granted use of the Research Institute.

Joint Usage Facilities for National Universities in the Chugoku/Shikoku Area:

Article 15 At the University, the Saijo Seminar House shall be established as a joint usage facility for national universities in the Chugoku/Shikoku area.

Joint Education and Research Facilities on Campus:

Article 16 The following facilities shall be established at the University as joint education and research facilities on campus.

Article 18 Matters necessary for education and research activities and management and operations of education and research organizations provided for in Article 6 through the preceding Article shall separately be determined.

## Chapter 3 Management Organizations

#### Directors:

- Article 19 At the University, the President, Executives (up to seven (7) (or up to eight (8) if one or more part-time Executives is assigned (such part-time Executives shall be any person other than the University's director or staff members at the time of appointment)) and Auditors (up to two (2)) shall be assigned as the Directors.
- 2. At least one of the two auditors stipulated in the preceding paragraph shall be assigned full-time.

Article 20 President represents the University and shall manage the operations as the final decision-maker of the University.

- 2. When making decisions on the following material matters, the President shall have deliberation and resolution of the Executive Board provided for in Article 24.
- (1) Opinions on the medium-term targets (opinions presented to the Minister of Education, Culture, Sports, Science and Technology under the Corporation Act, Article 30, paragraph 3) and the matters concerning annual plans.
- (2) Matters to be authorized or approved (except for the approval under Article 13-2, paragraph 1, and Article 17, paragraph 7, of the Corporation Act) by the Minister of Education, Culture, Sports, Science and Technology under the Corporation Act.
- (3) Matters concerning formulation, execution of budget and settlement of accounts.
- (4) Matters concerning establishment or abolition of graduate schools, majors and other important organizations of the University.
- (5) Matters concerning establishment, revision or repeal of the Policies and Regulations of the University and other regulations important for management and operations of the University.
- (6) Any other important matters determined by the Executive Board.
- 3. The Executives shall be in charge of the operations of the University, assisting the President and in case of absence or disability of the President, Executives shall act for the President and shall execute the duties of the President if the post of the President is vacant.
- 4. The Auditors shall audit the operations of the University.
- 5. Matters necessary for the Directors shall separately be determined.

#### Staff Members:

Article 21 At the University, faculty, clerical staff and technical staff and any other staff shall be assigned.

2 Matters necessary for staff members shall separately be determined.

#### Vice President:

- Article 22 A Vice President may be assigned at the University in order to assist the President in education, research and any other necessary fields in order to take charge of affairs of the University by the order of the President.
- 2. The Vice President shall be appointed from among the Executives.
- 3. Notwithstanding the preceding paragraph, the Vice President may be appointed from those other than the Executives.
- 4. Matters necessary for the Vice President shall separately be determined.

#### Counselor to the President:

- Article 22-2. A counselor to the President shall be appointed at the University who conducts an investigation on the general and financial management of the University and provides counsel to the President.
- 2. Matters necessary for the Counselor to the President shall separately be determined.

#### Assistant to the President:

- Article 23 An Assistant to the President may be appointed at the University in order to perform the specific operations, etc., instructed by the President.
- 2 Matters necessary for the Assistant to the President shall separately be determined.

# Vice Executives:

- Article 23-2 Vice Executives shall be assigned at the University in order to take charge of part of the operations of the Executives and assist the Executives.
- 2. Matters necessary for the Vice Executives shall separately be determined.

### **Executive Board:**

- Article 24 An Executive Board shall be established at the University in order to deliberate on important matters.
- 2. Matters necessary for operations, etc., of the Executive Board shall separately be determined.

# Administrative Council:

- Article 25 The Administrative Council shall be established at the University in order to deliberate on important matters concerning administration.
- 2. Matters necessary for operations, etc., of the Administrative Council shall separately be determined.

# **Education and Research Council:**

- Article 26 The Education and Research Council shall be established at the University in order to deliberate on important matters concerning education and research.
- 2. Matters necessary for operations, etc., of the Education and Research Council shall separately be determined.

### Other Management Organizations:

Article 27 In addition to those provided for in Article 19 through the preceding Article, matters

necessary for management organizations shall separately be determined.

Chapter 4 Other

Miscellaneous:

Article 28 In addition to those provided for herein, matters necessary for organizations and management of the University shall separately be determined.
