(April 1, 2004 Regulation No. 15)

Hiroshima University Regulations Regarding Student Life

Purpose:

Article 1. These Regulations prescribe matters that must be observed by students (hereafter, Students) in their student life at Hiroshima University (hereafter, This University), based on stipulations in Article 56, Paragraph 2, of Hiroshima University General Provisions (April 1, 2004 Regulation No. 2).

Student ID Card:

Article 2. Students shall be issued a student ID card that must be carried on his/her person at all times.

(2) Matters necessary to the handling of the student ID cards shall be separately prescribed.

Notification of Address:

Article 3. Students shall submit their address, the address of their family residence, and contact information (hereafter, Address, etc.) to the dean of the school of enrollment immediately following admission, using a predetermined form. When the Address, etc. changes, s/he must immediately make notification of that information.

Physical Examination:

Article 4. Students shall undergo a physical examination carried out by This University. However, when the physical examination cannot be taken due to unavoidable circumstances, students shall so notify the dean of the school of enrollment and receive instruction.

Registration of a Student Group:

Article 5. When Students create a group consisting of students from a single school, the head representative shall submit a predetermined notification of student group formation to the dean of the school to which the Students belong.

(2) When the group members are from 2 or more schools, the head representative shall submit a predetermined notification of student group formation to the president.

(3) When the activities of an organized group continue, a predetermined notification of renewal shall be submitted by the last day of May each year. In the case of a head representative of the student group set forth in Paragraph 1, it shall be submitted to the dean of the school of enrollment, and in the case of a head representative of a student group set forth in the preceding paragraph, it shall be submitted to the president.

(4) The following matters shall be listed in the notification stipulated in the preceding 3 paragraphs.

[1] The group's name

[2] The group's aims

- [3] Contact information
- [4] The name of the head representative
- [5] The number of members by school of enrollment
- [6] Names and contact information of the members of the group

Facility Utilization by Students or Student Groups:

Article 6. As a rule, when Students or student groups utilize facilities at This University (including athletic grounds, roads, etc.) (including the cases for distribution of written materials such as fliers and leaflets) the person in charge shall submit a predetermined application for facility utilization and obtain approval up to 3 days in advance. In the case of a school facility, it shall be submitted to the dean of the relevant school, and shall be submitted to the president for utilization of other facilities.

(2) The following matters shall be listed on the application for facility utilization stipulated in the preceding paragraph.

- [1] Purpose of utilization
- [2] Date, time, and location
- [3] The name of the person in charge
- [4] Participating members (including non-student members)

Noticeboards and Standing Signboards.:

Article 7. Notwithstanding the stipulations of the preceding Article, postings on noticeboards or standing signboards on campus by Students or student groups shall be conducted in accordance with the following prescriptions.

- [1] Notices shall be posted on predetermined student noticeboards.
- [2] Standing signboards shall be placed in predetermined students areas designated for posting.
- [3] Noticeboard postings shall be within 1m<sup>2</sup>, and standing signboards shall be within 2m<sup>2</sup> in size.
- [4] Postings and notices may be displayed for a period of up to 3 weeks. Postings and standing signboards that exceed that period shall be removed.

Events and Gatherings:

Article 8. In cases that Students or student groups carry out events or gatherings on campus, careful consideration must be given to ensure classes, research, medical services and examinations, etc., are not disturbed.

Matters to be Observed

Article 9. Students or student groups shall observe the laws and regulations and various regulations of This University and shall not disturb order or morals of This University.

Mutatis Mutandis Applications:

Article 10. The stipulations set forth in these regulations shall apply mutatis mutandis to Students of graduate schools and advanced courses.

(2) The stipulations of Article 2 through Article 4 shall apply mutatis mutandis to research students (including foreign research students, and the same applies hereinafter), credited auditors, short-term foreign exchange students, special research students, special auditing students, and Japanese language preparatory education students, while the stipulations of Articles 3 and 4 shall apply mutatis mutandis to research students and credited auditors.

Miscellaneous:

Article 11. In addition to the regulations prescribed here, matters necessary to the implementation of these regulations shall be separately prescribed.

#### Supplementary Provisions

1. This regulation shall come into effect from April 1, 2004.
2. When this regulation comes into effect, student ID cards issued in accordance with the former Hiroshima University Regulations Regarding Student Life (Hiroshima University Regulations of 1995 Regulation No. 4; hereafter, Former Regulations) shall be regarded as student ID cards issued in accordance with this regulation.
3. When this regulation comes into effect, student groups and notification of address submitted in accordance with the Former Regulations shall be regarded as student groups and notification of address submitted in accordance with this regulation.
4. When this regulation comes into effect, Students and student groups granted utilization approval in accordance with the Former Regulations shall be regarded as Students and student groups granted utilization approval in accordance with this regulation.

Supplementary Provisions (September 1, 2018 Regulation No. 117)

This regulation shall come into effect from September 14, 2018.

Supplementary Provisions (July 21, 2020 Regulation No. 189)

This regulation shall come into effect from July 21, 2020.
