

Written Pledge for Exceptional Overseas Student Dispatch or Travel

To Executive Vice President (Global Initiatives),

In this pledge I state my strong desire to travel or be dispatched overseas with agreement of my guardian/family and in accordance with Section 5 “Procedures for Overseas Dispatch” or Section 6 “Students Travelling Abroad Individually for Special Circumstances”.

In the event that I am granted permission to travel overseas, I pledge to act responsibly and stay cautious as a student of Hiroshima University, while complying with the following statements.

【Items】

1. I will comply with all preventive measures at times of entry into and departure from my destination country/region and Japan. (This includes confirmation that the destination country/region has not denied entry for those travelling from Japan.)
2. I will take measures to prevent infection, such as getting a COVID-19 vaccine before departure.
3. I will purchase health insurance to cover medical expenses in the event of an infection.
4. I will establish an emergency contact system with my academic advisor, the person in charge of the dispatch, my guardian and any other relevant persons prior to departure, and regularly report on my safety to those concerned after my departure.
5. I will register with MoFA Travel Registration Services “Tabi-Regi” before departure. If the planned period of dispatch is 3 months or more, I will register with ORRnet (Overseas Residential Registration) immediately after departure. (Japanese students only).
6. I will comply with local laws and regulations in my destination country/region, as well as the regulations of HU and my host university.
7. I will return to Japan as soon as possible if instructed to do so by HU due to security concerns in my destination country/region.
8. I will respond promptly to any other communication or instructions from HU.
9. I will not travel abroad until I have received formal permission from HU. (Note that if it is found that a student has traveled abroad without permission, HU may not approve any further overseas travel under this procedure.)
10. I understand Hiroshima University recommends vaccination against the novel coronavirus for overseas dispatch/travel. If for some reason I am unable or unwilling to get vaccinated, I am aware that I will be the one responsible for my concurrent travel decisions.

1. Print out this form, sign the pledge, and obtain the signature of the person in charge of the dispatch. Scan the signed document and upload as PDF through the Overseas Travel application system (MS Forms) when filling application.
2. In addition to this pledge, please make sure to also submit other documents required by your student support office before departure. Depending on the purpose of travel, your support office may require the "Temporary Return Home/External Travel Form" or "Application for Study Abroad" and "Emergency Contact Form" to your support office prior to your trip, depending on the purpose of your trip.

※ If the destination country/region's Level of Infectious disease warning is 2, this form should be submitted to the dean of the school.
