

Online Application for Enrollment Fee Exemption/Deferment and Tuition Fee Exemption User Manual for Students

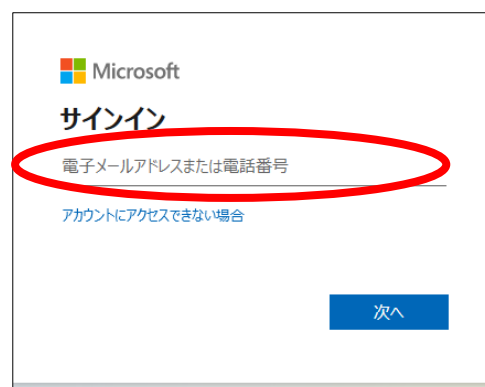
How to log in

1. Click on the URL for the online application (<https://forms.office.com/r/tUrn38jWjU>)
2. On the sing-in screen, enter your HU account (Student Number @hiroshima-u.ac.jp) and click the “次へ” button.

Be sure to sing in from your personal HU account
(IMC account) as of the application reference date.
(1st semester: April 1, 2026, 2nd semester: October 1, 2026)

***Note that students who advance from our university
must use the “new student number” account!!**

If you are automatically signed in with a different account,
please check and find out how to do this yourself, such as
clearing your browser's cache.



3. Enter the password and click the “サインイン” button.
4. Enter your response (No or Yes) about keeping your sign-in status.



How to make online application

1. Select the language (Japanese or English) and answer all questions.
2. Place a check mark in the “Send me an email receipt of my responses”.
3. Confirm your answers and click “Submit”.
4. Click on “Save my response” and save your response.
